

1 INTERIM STUDY PROPOSAL 2019-129

2
3 REQUESTING THE ARKANSAS LEGISLATIVE COUNCIL THAT THE SENATE
4 COMMITTEE ON CITY, COUNTY, AND LOCAL AFFAIRS CONDUCT AN INTERIM
5 STUDY TO DETERMINE THE BEST PRACTICES OF FIRE DEPARTMENTS IN THE
6 STATE AND IN THE NATION THAT MAY BE IMPLEMENTED IN A LOCAL
7 COMMUNITY TO IMPROVE EFFICIENCY.
8

9 WHEREAS, because of the rural nature of local communities that are
10 served by many fire departments in the state, the responsibilities of a fire
11 department include more than just fire protection, including without
12 limitation providing assistance for medical calls, rescues, and other
13 emergency services; and
14

15 WHEREAS, a large number of fire departments are staffed by an aging
16 population of volunteers and fire departments are currently having a
17 difficult time obtaining new volunteers and keeping experienced volunteers;
18 and
19

20 WHEREAS, there are over nine hundred (900) fire departments in the
21 state and many of these fire departments overlap service areas of other
22 jurisdictions or cover areas that are too large to provide adequate fire
23 protection; and
24

25 WHEREAS, there is no central means of communication to and for these
26 fire departments and no statewide coordinator; and
27

28 WHEREAS, data collection across the state is needed to gather
29 information on equipment supply and demand, funding issues, and other related
30 areas; and
31

32 WHEREAS, national and state research should be analyzed to study
33 possible improvements to the public protection classification system used by
34 the state to evaluate the fire loss risk of local communities and its impact
35 on property insurance rates; and

1 WHEREAS, there are a number of fire departments that operate within
2 municipalities for municipalities with no organized municipal fire
3 department; and the procedures and challenges for these departments need to
4 be examined; and
5

6 WHEREAS, there is consistent misuse of fire department funds, creating
7 a need for a uniform audit mechanism to be put in place; and
8

9 WHEREAS, there are a number of different types of fire departments in
10 the state, resulting in a lack of uniformity in business structure and
11 operation that is confusing for property owners, insurance companies, and
12 fire departments themselves; and in light of recent legislation affecting
13 fire protection districts, the differences in departments need to be examined
14 and compared to determine advantages and disadvantages of the types of fire
15 department organization,
16

17 BE IT PROPOSED BY THE SENATE COMMITTEE ON CITY, COUNTY, AND LOCAL AFFAIRS OF
18 THE NINETY-SECOND GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19

20 THAT the Senate Committee On City, County, And Local Affairs conduct an
21 interim study to determine the best practices of fire departments in the
22 state and in the nation that may be implemented in a local community to
23 improve efficiency.
24

25 BE IT FURTHER PROPOSED THAT the study review and analyze the impact of
26 an increase in funding to volunteer fire departments.
27

28 BE IT FURTHER PROPOSED THAT the study review the role of fire
29 departments including without limitation response to fires, medical
30 assistance calls, rescues, and other emergency services.
31

32 BE IT FURTHER PROPOSED THAT the study review and analyze potential
33 incentives and methods to recruit and retain volunteers for volunteer fire
34 departments.
35

1 BE IT FURTHER PROPOSED THAT the study review the number of volunteer
2 fire departments and any available resources in the state to determine the
3 most efficient organization and operation of volunteer fire departments and
4 evaluate if consolidation of fire departments or other options or measures
5 are necessary to improve efficiency.

7 BE IT FURTHER PROPOSED THAT the study review any and all other
8 pertinent information related to this endeavor.
