

MINUTES OF THE MEETING
OF THE
ARKANSAS LEGISLATIVE COUNCIL

Friday, June 21, 2019

The Arkansas Legislative Council met at 9:00 a.m., Friday, June 21, 2019, in Committee Room A of the Big Mac Building, Little Rock, Arkansas. Co-Chair Cecile Bledsoe called the meeting to order and recognized a quorum of members present. The members present are listed on the sign-in sheets.

Minutes of the Previous Meeting

Co-Chair Bledsoe referred the members to the minutes of the last Legislative Council meeting on May 17, 2019 (Exhibit C) and asked if there were any questions. There were no questions.

Senator Terry Rice moved that the minutes of the May 17, 2019 meeting of the Legislative Council be adopted. The motion was seconded and passed by voice vote.

May 2019 Revenue Report

Co-Chair Bledsoe recognized Richard Wilson, Assistant Director for Research Services of the Bureau of Legislative Research to present the May 2019 Arkansas Revenue Report (Exhibit D). Mr. Wilson reported that after eleven (11) months of Fiscal Year 2019, gross general revenue collections are \$416 million above collections during the same period last year for a growth rate of six point nine percent (6.9%). Mr. Wilson reported that net general revenues available are \$332 million above collections during the same period last year for a growth rate of six point seven percent (6.7%). Mr. Wilson reported the graph reflects that after a few good months, gross collections are \$174 million above the official forecast. Mr. Wilson reported that the spreadsheet reflects that the gross receipts are growing at two point three percent (2.3%), and income tax collections are at ten point seven percent (10.7%). This concluded the May 2019 general revenue report, and there were no questions.

Report of the Executive Subcommittee

Co-Chair Bledsoe recognized Co-Chair Jeff Wardlaw to present the Report of the Executive Subcommittee (Exhibit E). Co-Chair Jeff Wardlaw reported that the Executive Subcommittee met on June 20, 2019, and reviewed and approved emergency rules for the Commissioner of State Lands and the review and approval will be effective upon adjournment of the Legislative Council meeting today.

Co-Chair Wardlaw reported that the Executive Subcommittee also discussed cancelling the July 2019 Legislative Council meeting to avoid conflicts with the legislative conferences schedule, and voted to recommend that the July 2019 Legislative Council meeting be cancelled, and that July subcommittee meetings be moved to either July 18, 2019 or July 19, 2019, if a subcommittee chooses to meet. The Executive Subcommittee recommends that the actions of the Legislative Council subcommittees that would normally be submitted for adoption at the July 2019 meeting of

the Legislative Council be considered final and reported to the Legislative Council at the August 2019 meeting, except that final action not be granted to the Administrative Rules Subcommittee with regard to the Department of Health rules and regulations pertaining to Food Service Establishments.

Co-Chair Wardlaw reported that the Executive Subcommittee also voted to recommend that the August 2019 meeting of the Legislative Council be moved to August 23, 2019, and that all the August subcommittee meetings be moved to that week. Co-Chair Wardlaw explained that this recommendation was due to a legislative conference scheduled during the week when the Legislative Council would normally meet. This concluded the Executive Subcommittee Report, and Co-Chair Wardlaw responded to questions.

Co-Chair Jeff Wardlaw moved that the Executive Subcommittee Report be adopted.

Co-Chair Bledsoe recognized Senator Terry Rice, who asked that the motion include that if a subcommittee member objects to the subcommittee action on an item on the subcommittee's July agenda, that the item be deferred to the next meeting of the subcommittee. Co-Chair Wardlaw agreed to amend his motion to include this language.

Co-Chair Bledsoe asked for a second on the motion by Co-Chair Jeff Wardlaw to adopt the report of the Executive Subcommittee including the following recommendations:

(1) the July 19, 2019 Legislative Council meeting is cancelled and July subcommittee meetings are moved to either July 18, 2019 or July 19, 2019, with the actions of the subcommittees being final with these exceptions:

(a) final action is not granted to the Administrative Rules Subcommittee with regard to the Department of Health rules and regulations pertaining to Food Service Establishments; and (b) if a subcommittee member objects to the subcommittee action on an item on the subcommittee's July agenda, that item will be deferred to the next meeting of the subcommittee; and

(2) the regular August 2019 meeting of the Legislative Council be moved to August 23, 2019, and all Legislative Council subcommittee meetings are moved to the week that begins with August 19, 2019.

The motion was seconded and passed by voice vote.

Reports of the Standing Subcommittees

Administrative Rules Subcommittee

Co-Chair Bledsoe recognized Representative Dan Sullivan to present the report of the Administrative Rules Subcommittee (Exhibit F.1). Representative Sullivan reported that the Administrative Rules Subcommittee met on June 19, 2019, and reviewed and approved all rules on the agenda, with the following exceptions:

(1) the Department of Finance and Administration, Office of State Procurement rule (see item 2.a. on page 2 of the report) was deferred to the August 2019 meeting of the subcommittee; and

(2) the Department of Health rule pertaining to food service establishments (see item 3.a. on page 2 of the report) was referred to the House and Senate Committees on Public Health, Welfare, and Labor for further discussion and consideration at the committees' July 8, 2019 meeting; and therefore, deferred to the July meeting of the Administrative Rules Subcommittee for final review and approval.

This concluded the report of the Administrative Rules Subcommittee, and there were no questions.

Representative Dan Sullivan moved that the report of the Administrative Rules Subcommittee be adopted. The motion was seconded and passed by voice vote.

Claims Review Subcommittee

Co-Chair Bledsoe recognized Senator Bart Hester to present the report of the Claims Review Subcommittee (Exhibit F.3). Senator Hester reported that the Claims Review Subcommittee met on June 17, 2019, and the subcommittee affirmed the ruling of the Arkansas State Claims Commission on five (5) awarded claims, five (5) claims denied and dismissed and appealed by the claimants, and reversed the Arkansas State Claims Commission ruling in *Ellis Sloan vs Arkansas Public Employees Retirement System* and remanded that claim back to the Arkansas State Claims Commission for a hearing on the merits of the claim. This concluded the report of the Claims Review Subcommittee, and there were no questions.

Senator Bart Hester moved that the report of the Claims Review Subcommittee be adopted. The motion was seconded and passed by voice vote.

Game and Fish/State Police Subcommittee

Co-Chair Bledsoe recognized Senator Terry Rice to present the report of the Game and Fish/State Police Subcommittee (Exhibit F.4). Senator Rice stated he is presenting the report for Representative Josh Miller. Senator Rice reported that the Game and Fish/State Police Subcommittee met on June 18, 2019, and heard and discussed testimony regarding the rules and regulations adopted by the Arkansas Game and Fish Commission, and an update on Chronic Wasting Disease from Cory Gray, Division Manager with the Game and Fish Commission. Senator Rice reported that the subcommittee also discussed the applications for a concealed-handgun-carry license for Colonel Bryant, Director, and Ms. Mary Claire McLaurin, Staff Attorney, with the Arkansas State Police. This concluded the report of the Game and Fish/State Police Subcommittee, and there were no questions.

Senator Terry Rice moved that the report of the Game and Fish/State Police Subcommittee be adopted. The motion was seconded and passed by voice vote.

Higher Education Subcommittee

Co-Chair Bledsoe recognized Representative David Whitaker to present the report of the Higher Education Subcommittee (Exhibit F.5). Representative Whitaker reported that the Higher Education Subcommittee met on June 20, 2019, and heard testimony and discussed the overview of the Department of Higher Education presented by Ann Clemmer, Senior Associate Director, and Nick Fuller, Deputy Director, during which it was noted that higher education institutions receive \$900 million annually in state dollars.

Representative Whitaker reported that the subcommittee heard an overview of Arkansas community colleges from Collin Callaway, Chief Operations Officer. Ms. Callaway noted that the colleges serve 65,000 students annually, of whom thirty-one percent (31%) are racial and ethnic minorities, and that fifty-seven percent (57%) of the student population are part-time students.

Representative Whitaker reported that the subcommittee also discussed topics for future subcommittee meetings. This concluded the report of the Higher Education Subcommittee, and there were no questions.

Representative David Whitaker moved that the report of the Higher Education Subcommittee be adopted. The motion was seconded and passed by voice vote.

Litigation Reports Oversight Subcommittee

Co-Chair Bledsoe recognized Senator Bob Ballinger to present the report of the Litigation Reports Oversight Subcommittee (Exhibit F.7). Senator Ballinger reported that the Litigation Reports Oversight Subcommittee met on June 20, 2019, and reviewed three (3) settlement agreements, and two (2) matters of ongoing litigation. This concluded the report of the Litigation Reports Oversight Subcommittee, and there were no questions.

Senator Bob Ballinger moved that the report of the Litigation Reports Oversight Subcommittee be adopted. The motion was seconded and passed by voice vote.

Performance Evaluation and Expenditure Review (PEER) Subcommittee

Co-Chair Bledsoe recognized Representative DeAnne Vaught to present the report of the Performance Evaluation and Expenditure Review (PEER) Subcommittee (Exhibit F.8). Representative Vaught reported that the subcommittee met on June 18, 2019, and approved four (4) items: (1) a reallocation of resources for the Department of Human Services; (2) requests for appropriation transfer from the Minority Health Commission and the Department of Human Services; (3) a request to maintain the current percentage deduction from general and special revenues for the State Central Services Fund; and (4) a Rainy Day Fund transfer to the Department of Arkansas Heritage.

Representative Vaught reported that the subcommittee reviewed several items, including the following: cash fund appropriation requests; cash fund appropriation increase requests; a budget classification transfer request for fiscal year 2019; budget classification transfer requests for fiscal year 2020; miscellaneous federal grant appropriation requests for both fiscal year 2019 and fiscal year 2020; requests for the continuation of fiscal year 2020 miscellaneous federal grants; requests for performance fund/pay plan holding account funding; tobacco settlement account carry-forward

funding requests, and various reports assigned to the subcommittee. This concluded the report of the Performance Evaluation and Expenditure Review (PEER) Subcommittee.

Representative DeAnne Vaught moved that the report of the Performance Evaluation and Expenditure Review (PEER) Subcommittee be adopted.

Co-Chair Bledsoe recognized Senator Bob Ballinger for a question, who asked for further explanation of the Rainy Day Fund transfer to the Department of Arkansas Heritage. Co-Chair Bledsoe recognized the following officials to come forward to respond to questions: Jake Bleed, Director, Office of Budget with the Department of Finance and Administration; Stacy Hurst, Director of the Arkansas Department of Heritage; David Bell, Chief Fiscal Officer of the Arkansas Department of Heritage; and Michael Grappe with the Arkansas Department of Environmental Quality.

During the discussion that followed, the following information was provided by these officials:

- The agreement is to purchase in perpetuity a conservation easement for property in the Buffalo River watershed basin.
- The request presented to the PEER Subcommittee was for approval to transfer up to \$6.2 million from the Rainy Day Fund, as well as a cash-letter appropriation for this fiscal year and continuing into the next fiscal year to allow the purchase of the easement.
- Under the agreement with the property owners, the funds will be placed into an escrow account, and when the proper amount in the escrow account is reached, the parties will begin performance under the contract and once performance is completed, the funds will be withdrawn from the escrow account and the transaction will be completed.
- The agreement allows for the purchase of a conservation easement on the twenty-three (23) plus acres where C & H Farms currently operates a concentrated animal feeding operation (CAFO).
- The agreement has been released publicly, and under the terms of the agreement, C & H Farms retains fee title to the land and limited farming can be done on the acreage, but there will be restrictions placed on the land, one of which is that there will not be the ability to operate a CAFO.
- Three (3) performance documents are being finalized and are included as part of the agreement. One of the performance documents requires the Department of Environmental Quality (ADEQ) to manage the clean-up of the site, and all parties will have to agree that the site has been cleaned up.
- It is anticipated that the performance documents will be finalized within a couple of weeks, and the funds can then be transferred into escrow. This request was added to a supplemental agenda for the PEER Subcommittee due to the nature of the negotiations, the subcommittee's review was needed before the August meeting of the subcommittee.
- There is the expectation of a \$1 million private donation from the Nature Conservancy that will move into the cash fund appropriation that will be used to complete the transaction.
- There are plans to continue sampling of the water, and the results can be made available to the General Assembly members.

- The preliminary agreement does not include language that states that the conservation easement is in a first-lien position and is superior to any other liens that may be on the property.
- C &H Farms received a permit from the Arkansas Department of Environmental Quality under Regulation 6, which is no longer supported by the Environmental Protection Agency (EPA).
- The Arkansas Department of Heritage has the statutory authority to acquire easements and acquire land for conservation purposes.
- The Arkansas Department of Environmental Quality does not have an estimate at this point of the cost to clean up the property because an on-site assessment has not yet been made.
- The funding for this easement is separate from funds that would be used to respond to natural disasters such as the recent flooding along the Arkansas River.
- It is anticipated that when the contract and performance measures are finalized, the property owners can begin accessing the funds in the escrow account within four (4) to six (6) months.
- The approval of the cash fund appropriation request could not wait until the August meeting of the subcommittee because the parties are not required to begin performing under the contract until the funds are moved into the escrow account and both parties are anxious to move forward.
- Because this is a real estate transaction, the final agreement is not required to come back before the Legislative Council; however, the final accounting could be provided to the members.

Co-Chair Bledsoe recognized Senator Missy Irvin who stated that the motion passed in the PEER Subcommittee meeting was that a full accounting of the expenditure of the funds, the amount of the contribution from the Nature Conservancy, and a detailed accounting of expenses incurred by the Department of Environmental Quality on the clean-up of the site will come before the PEER Subcommittee. Co-Chair Bledsoe noted that the motion referenced by Senator Irvin can be found on page 2 of the subcommittee report as item C.4.

With the conclusion of the discussion of the motion, Co-Chair Bledsoe noted that the motion on the floor is Representative Vaught's motion to adopt the report. Co-Chair Bledsoe recognized Senator Jimmy Hickey, who stated he would like to offer a substitute motion unless the original motion is amended to make approval contingent upon the conservation easement being in a priority position before other liens on the property. Representative Vaught agreed to amend her motion.

Co-Chair Bledsoe asked Marty Garrity, Executive Secretary of the Legislative Council, to respond to questions. Ms. Garrity clarified that the options before the committee are: (1) to refer this request back to the PEER Subcommittee for consideration in the July 2019 meeting and give the subcommittee final approval contingent on that language being in the contract; or (2) consider an emergency action on the contract that is revised to add the language, which would require the approval of the Co-Chairs of the PEER Subcommittee and the Co-Chairs of the Legislative Council.

There followed further discussion of the motion and on the contract. Co-Chair Bledsoe asked Ms. Garrity to respond to questions. Ms. Garrity clarified that a motion to vote on this item separately

from the adoption of the PEER Subcommittee Report is needed, and then the committee may consider the options to revise the contract.

Co-Chair Bledsoe recognized Representative Vaught who moved that the report of the Performance Evaluation and Expenditure Review (PEER) Subcommittee be adopted, with the exception of the Rainy Day Fund Transfer to the Department of Arkansas Heritage, listed as item C.4. on page 2 of the report, with that item to be considered separately. The motion was seconded and passed by voice vote.

Co-Chair Bledsoe recognized Senator Irvin who asked if the attorneys for all parties could be called before the committee today to respond to questions. Ms. Hurst responded that their attorney is out of town today. Co-Chair Bledsoe stated that the options before the committee are to consider this item today in this committee, or to refer the item back to the PEER Subcommittee for consideration. There followed further discussion among the committee members.

Co-Chair Bledsoe recognized Senator Hester for a motion. Senator Bart Hester moved that the Legislative Council authorize the Co-Chairs of the Legislative Council to approve on an emergency basis, the Rainy Day Fund Transfer to the Department of Arkansas Heritage, listed as item C.4. on page 2 of the report, when they are assured that the conservation easement will be in a first-lien position in the agreement between the parties. The motion was seconded and passed by a voice vote.

Review Subcommittee

Co-Chair Bledsoe recognized Senator Scott Flippo to present the report of the Review Subcommittee (Exhibit F.10). Senator Flippo reported that the Review Subcommittee met on June 18, 2019, and reviewed all of the agenda items concerning methods of finance, general construction projects exceeding \$5 million, grants, and contracts. Senator Flippo reported that no items were held. This concluded the report, and there were no questions.

Senator Scott Flippo moved that the report of the Review Subcommittee be adopted. The motion was seconded and passed by voice vote.

Uniform Personnel Classification and Compensation Plan Subcommittee

Co-Chair Bledsoe recognized Senator David Wallace to present the report of the Uniform Personnel Classification and Compensation Plan Subcommittee (Exhibit F.11). Senator Wallace reported that the Uniform Personnel Classification and Compensation Plan Subcommittee met on June 18, 2019, and reviewed communications and reports, which included notice from Arkansas Rehabilitation Services of a Reduction in Force that will eliminate 107 employee positions.

Senator Wallace reported that the subcommittee also reviewed action items, which include: authority to pay three (3) department secretaries above the maximum salary of their grade; a request for continuation of differentials; the report of special-entry rates and labor-market rates; and a report of pool positions. This concluded the report, and there were no questions.

Senator David Wallace moved that the report of the Uniform Personnel Classification and Compensation Plan Subcommittee be adopted. The motion was seconded, and passed by voice vote.

Lottery Oversight Subcommittee

Co-Chair Bledsoe recognized Representative Chris Richey to present the report of the Lottery Oversight Subcommittee (Exhibit F.12). Representative Richey reported that the Lottery Oversight Subcommittee met on June 3, 2019, and heard an informational overview of the activities and operations of the Office of the Arkansas Lottery from Bishop Woosley, Director of the Office of Arkansas Lottery. Representative Richey reported that the subcommittee also reviewed the annual budget for fiscal year 2020 for the Office of the Arkansas Lottery, and the fiscal year 2020 budget for the Arkansas Department of Higher Education for expenses incurred in administering the Academic Challenge Scholarship program. This concluded the report of the Litigation Reports Oversight Subcommittee, and there were no questions.

Representative Chris Richey moved that the report of the Lottery Oversight Subcommittee be adopted. The motion was seconded and passed by voice vote.

Highway Commission Review and Advisory Subcommittee

Co-Chair Bledsoe recognized Representative Ron McNair to present the report of the Highway Commission Review and Advisory Subcommittee (Exhibit F.13). Representative McNair reported that the Highway Commission Review and Advisory Subcommittee met on June 19, 2019, and discussed the issue of only receiving one (1) proposal submitted in response to the RFP for consulting services to conduct the study of the Department of Transportation. Representative McNair reported the subcommittee decided to move forward with the original RFP timeline, and will meet in July 2019 to hear the vendor's proposal. This concluded the report, and there were no questions.

Representative Ron McNair moved that the report of the Highway Commission Review and Advisory Subcommittee be adopted. The motion was seconded, and passed by voice vote.

Occupational Licensing Review Subcommittee

Co-Chair Bledsoe recognized Senator Missy Irvin to present the report of the Occupational Licensing Review Subcommittee (Exhibit F.15). Senator Irvin reported that the Occupational Licensing Review Subcommittee was created by the Legislative Council on May 17, 2019, and met on June 20, 2019 for the inaugural organizational meeting. Senator Irvin reported that the subcommittee adopted the subcommittee rules, divided the occupational entities into groups for systematic review, and discussed a tentative timeline for review of the first group. This concluded the report, and there were no questions.

Senator Missy Irvin moved that the report of the Occupational Licensing Review Subcommittee be adopted. The motion was seconded and passed by voice vote.

Reports of Interim or Special Committees

Co-Chair Bledsoe recognized Senator Breanne Davis to present the report of the Joint Committee on Advanced Communications and Information Technology. Senator Davis reported that the Joint Committee on Advanced Communications and Information Technology met on June 5, 2019, and reviewed the request from the Department of Information Systems on proposed new rates of

service effective July 1, 2019 for fiscal year 2020. Senator Davis reported that the proposed rates are to more properly align cost with the benefit being received by the customer agencies and to allocate cost to federal awards in accordance with applicable requirements.

Senator Davis reported that the Joint Committee on Advanced Communications and Information Technology has favorably reviewed the request from the Department of Information Systems. This concluded the report, and there were no questions. Co-Chair Bledsoe noted that no action by the Legislative Council is required on the committee's report.

Review of Communications

Co-Chair Bledsoe referred members to the communications listed as Exhibit H.1 through Exhibit H.14 on the agenda, and noted that action by the Legislative Council is needed for the following items:

- 1) Arkansas Agriculture Department request for the Legislative Council's review of the sale of property below the appraised price, submitted pursuant to A.C.A. § 22-6-601(h)(2);
- 2) Arkansas Teacher Retirement System request for the Legislative Council's review of the partial equity ownership investments with JFL Equity Investors V, L.P.; Franklin Park Venture Fund Series 2019, L.P.; and Franklin Park Corporate Finance Access Fund, L.P.; and
- 3) Arkansas Department of Information Systems request for the Legislative Council's review of proposed new rates of service for fiscal year 2020, submitted pursuant to A.C.A. § 25-4-119(b)(3)(B).

Co-Chair Bledsoe asked if there were any questions or discussion regarding the other items listed under Communications. There were no questions concerning the other communications listed on the agenda.

Arkansas Agriculture Department

Co-Chair Bledsoe asked if there were any questions on the request for the Legislative Council's review of the sale of the Arkansas Forestry Commission property below the appraised price (Exhibit H.1). Seeing none, Co-Chair Bledsoe asked if there was a motion.

Representative Jeff Wardlaw moved that the sale of the Arkansas Forestry Commission property below the appraised price be filed as reviewed by the Legislative Council. The motion was seconded and passed by voice vote.

Arkansas Teacher Retirement System (ATRS)

Co-Chair Bledsoe asked if there were any questions on the Arkansas Teacher Retirement System request for the Legislative Council's review of the partial equity ownership investments with JFL Equity Investors V, L.P.; Franklin Park Venture Fund Series 2019, L.P.; and Franklin Park Corporate Finance Access Fund, L.P. (Exhibit H.5). Seeing none, Co-Chair Bledsoe asked if there was a motion.

Representative Jeff Wardlaw moved that the Arkansas Teacher Retirement System partial equity ownership investments with JFL Equity Investors V, L.P.; Franklin Park Venture Fund Series 2019, L.P.; and Franklin Park Corporate Finance Access Fund, L.P. be filed as reviewed by the Legislative Council. The motion was seconded and passed by voice vote.

Department Information Systems

Co-Chair Bledsoe asked if there were any questions on the Department of Information Systems' request for the Legislative Council's review of the proposed new rates of service for fiscal year 2020, submitted pursuant to A.C.A. § 25-4-119(b)(3)(B) (Exhibit H.13). Seeing none, Co-Chair Bledsoe asked if there was a motion.

Representative Jeff Wardlaw moved that the Department of Information Systems proposed new rates of service for fiscal year 2020 be filed as reviewed by the Legislative Council. The motion was seconded and passed by voice vote.

Interim Study Proposals

Co-Chair Bledsoe referred members to the new interim study proposals listed as Exhibit J.1 through Exhibit J.5 on the agenda, and stated these interim study proposals could be considered together with the exception of Interim Study Proposal 2019-127 (Exhibit J.4).

Co-Chair Bledsoe asked if there were any questions or discussion concerning Interim Study Proposal 2019-124, Interim Study Proposal 2019-125, Interim Study Proposal 2019-126, or Interim Study Proposal 2019-129. Seeing none, Co-Chair Bledsoe asked if there was a motion.

Representative Jeff Wardlaw moved that Interim Study Proposal 2019-124, Interim Study Proposal 2019-125, Interim Study Proposal 2019-126, and Interim Study Proposal 2019-129 be referred to the appropriate committee for study. The motion was seconded and passed by voice vote.

The following interim study proposals were referred by the Legislative Council to the committees as follows:

1. Interim Study Proposal 2019-124, by Representative Julie Mayberry, is referred to the House Committee on Revenue and Taxation;
2. Interim Study Proposal 2019-125, by Representative Julie Mayberry, is referred to the House Committee on Revenue and Taxation;
3. Interim Study Proposal 2019-126, by Representative Jack Ladyman, is referred to the House Committee on Revenue and Taxation;
4. Interim Study Proposal 2019-129, by Senator Kim Hammer, is referred to the Senate Committee on City, County, and Local Affairs.

Co-Chair Bledsoe referred to Interim Study Proposal 2019-127 (Exhibit J.4), by Representative Jana Della Rosa, which is a bill to create a study of public notice and participation in the

environmental permitting process, and asked if there were any questions. Seeing none, Co-Chair Bledsoe asked if there was a motion.

Senator Missy Irvin moved that Interim Study Proposal 2019-127 be referred to the House Committee on City, County, and Local Affairs. The motion was seconded and passed by voice vote.

Adjournment

At 10:10 a.m., the meeting was adjourned as there was no further business to come before the Legislative Council.
