SUBJECT: COLLECTION AND DISTRIBUTION OF GENERAL AND SPECIAL REVENUES - 2018-2019

Attached is the 2018-2019 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2018-2019 fiscal year. In summary, Gross General Revenue collections of approximately \$7,238.6 million increased \$500.3 million or 7.42% above the \$6,738.3 million collected in fiscal year 2017-18. Adjusted Net General Revenues available for distribution of \$5,921.4 million increased \$426.5 million or 7.76% above the \$5,494.9 million available for distribution in fiscal year 2017-18. Gross Special Revenues of \$2,293.0 million increased \$42.7 million or 1.9% more than the \$2,250.3 million collected in fiscal year 2017-18.
