Re: Arkansas Forestry Commission monthly activity report for April 2018

Dear Senator Sample and Representative Dotson:

Per Section 42 of Act 841 of the 2017 Regular Session, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for April 2018.

April brought another great opportunity for Arkansas to help out its neighboring state, Oklahoma. The AFC received a request to send nine plow units and thirteen operators to assist Oklahoma with wildfire suppression.

The crews from AFC responded and worked several fires in Oklahoma including the Rhea Fire that burned over 286,000 acres.

With April showers and unseasonable warm temperatures, spring "Green-up" allowed the southern half of the state to respond to help our neighboring state.

At AFC, we keep Arkansans safe from wildfires and help neighboring states with emergency response when conditions allow.

April 2018 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During April a total of 129 wildfires were suppressed for a total of 3,557 acres burned. Ten-year average for the month of April is 118 wildfires for 1,967 acres burned.

Search and Rescue Assistance: An AFC crew was requested by the Newton County Sheriff's office to help carry out an injured hiker. The hiker slipped on a rock and dislocated his hip and broke his leg. It was about three miles in to where the injured person was located and a strenuous three mile carry out to safety.

Storm Damage Assistance: Two AFC Crawford County rangers assisted in clearing debris from roads in the Mountainburg area after tornado activity. A ranger in Conway County assisted in clearing debris from roads in the Oppelo area as well.

Rural Fire Protection: Rural Fire Protection (RFP) assists fire departments (FDs) with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 fire departments. The RFP shop also provides maintenance to AFC equipment.

APRIL 2018

- 58 fire departments, (162 firefighters), were provided wildland fire training, including two minority departments and four AFC/AAD personnel in attendance.
- RFP received four Freightliners (valued at \$661,966.00) and two AM Generals/ Tankers (valued at \$114,908.00).
- There were eight Department of Defense (DOD) vehicles and other equipment issued to FDs including one Freightliner (valued at \$166,223.00), five brush trucks (valued at \$330,005.43), two service trucks (valued at \$29,185.97) and one generator with trailer (valued at \$20,039.00).
- 390 DOD Recycling Control Point (RCP) items were received for redistribution to FDs (valued at \$47,519.93) including: Spine boards, burn packs, flashlights, folding cots, funnels and fire hose reducers.
- The RFP shop completed maintenance on nine AFC vehicles and six DOD vehicles.
- RFP provided two interest free loans via the Rural Fire Revolving Loan Fund.

 - Galla Rock VFD \$9,452.00 Water skid, Pump & engine, '85 Chevy Yell Co. D-
- 2017 Wildfire Volunteer Fire (WFVF) Grant update- All items for the grant kits have been ordered. We are currently expecting delivery of PPE by the end of June.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education

initiatives. Arkansas leads the nation with 167 active Firewise communities. Recognized communities display Firewise signs at the city limits.

- Attended Emergency Preparedness Day in Hot Springs Village to address the risk associated with living in the wildland-urban interface and activities that can be done to reduce those threats.
- Attended Commissioner's Meeting at District 7 to update board members on the Firewise program and staff efforts.
- Organized photoshoot with Firewise USA/NFPA Program Coordinator to showcase one of Arkansas' top Firewise communities and their efforts.
- Delivered one risk assessment training presentation.

Law Enforcement: AAD has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AAD aggressively seeks prosecution of violators to deter such crimes.

- AAD Investigators and district law enforcement officers opened five dumping, 16 fire related, one equipment theft/ vandalism, and nine timber theft cases.
- They closed eight dumping, four fire related, one equipment theft/vandalism, and seven timber theft cases.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 5,061 landowners owning 935,949 acres that have enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,241 Forest Stewards owning 281,189 acres.

For April, four FSP plans were prepared on 262 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention Program. AFC foresters prepared 32 rural forestry management plans on 3,239 acres. AFC personnel conducted 19 prescribed burns on 2,067 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Urban forestry has been implementing programs and planning more progress for the future. April has been a month filled with tree celebrations. National Arbor Day and Earth Day events occurred in April. Communities can celebrate Arbor Day on any day that works best for them. Tree City USA communities had extremely high participation. Communities that participated this month include: Maumelle, Morrilton, UAMS, Eureka Springs, West Fork, North Little Rock, Bella Vista, Hot Springs, Walnut Ridge, Pleasant Planes and Jonesboro.

- Urban Forestry Staff also assisted Arkansas Urban Forestry Council's annual retreat to help prepare their five year strategic plan.
- Staff presented fruit and tree care to the community of Mountain home and Garvan Woodland Gardens.
- Staff set up and trained D3 personnel to conduct a tree inventory for the community of Wynne.
- Staff continues to publish a monthly article for City and Town. This month also marked the first issue of our newsletter to our Tree City USA communities.

Forest Health: The Forest Health Specialist, Chandler Barton, assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

- Loblolly pine sawfly, *Neodiprion taedae linearis*, caused widespread pine defoliation in southern and central Arkansas. Annually, the insect is present in Ashley county, but it could be found in counties along the Ouachita River and as far north as White county. Although it appears to be a problem, the defoliation does not kill the tree since new growth replaces the lost needles.
- Southern pine beetle traps were placed in March. Preliminary results of the survey does not indicate that SPB abundance is high enough to warrant outbreak concerns in 2018.

Reforestation: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

On April 10, Reforestation Manager and Tree Improvement Manager met with U of A Cooperative Extension Service and U of A Monticello representatives at the Hope Agricultural Experiment Station to develop a site prep plan for the containerized loblolly pine vs bare root loblolly pine study.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15

- Through April 30, there were 787 on line orders and 245 traditional orders
- Total sales of 1,570,475 pine and 5,161,721 hardwood
- Comparatively, in the same period in FY 17, there were 543 on line orders and 179 traditional orders
- Total sales of 2,351,895 pine and 5,013,625 hardwood

During the month of April, Baucum Nursery staff completed the following.

- Disc and used do-all in fields
- Tilled field 4 and 7.
- Sprayed Round up on the ends of all fields, around power poles and equipment.
- Used roller to push seed back into the ground that birds pulled up.
- Set up irrigation system in planted fields.
- Pulled weeds in field 7.

- Bush hogged unsold pine in field 2 in preparation for plowing under.
- Repaired broken welds on hardwood planter.
- Applied saw dust over exposed seeds.
- Repaired hydraulic hose on backhoe.
- Pushed up mulch/wood chip pile with dozer.

Tree Improvement:

During the month of April, the Bluff City Tree Improvement staff completed the following.

- Removed bags from trees for 19 control cross pollinations.
- Moved 820 grafts out of greenhouse to shade house.
- Inventoried orchard 1720 and 1721.
- Sprayed roundup over water lines in 1720 and started 1721.
- Filled 150 trays with soil for planting of three star loblolly pine seedlings.
- Filled 600, three gal pots with soil and planted hardwoods for rootstock.
- Filled 1,200, three gal pots with soil and planted pine for rootstock.
- Bush hogged hay field.
- Collected soil samples from hardwood orchard sites.
- Fertilized orchards 1710 and 1721 according to WGFTIP recommendation.
- Began site prep for containerized vs bare root loblolly pine test at U of A Experiment Station at Hope.
 - Removed stumps on approximately 10 ac.
- Shipped eight WWI Memorial trees.
- Picked up loblolly and shortleaf seed from Oklahoma Forestry Services where cones were processed.
 - Seed was then delivered to the freezer at Baucum.
- Picked up cone crates from Oklahoma Forestry Services
- Took seed samples to Arborgen for testing germination, purity and seed per pound calculation.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

The BMP Coordinator conducted one courtesy exam in Conway County with four participants. Participants consisted of three Foresters and AFC's BMP coordinator. The exam addressed the Arkansas Forestry Commissions BMP Program. The BMP Coordinator provided copies of Arkansas' BMP Implementation Reports, AFC's manual "BMPs for Water Quality Protection", the water quality

complaint process and MOU with ADEQ. The BMP coordinator provided an overview of the entire program and offered technical assistance, and training to help with their SFI program and audits.

The BMP Implementation Survey update: BMP Coordinator finished the ground surveys, collecting data on 237 randomly selected logging sites. The next step is to analysis the data and write a final report to be printed in June 2018.

The BMP coordinator attended and participated in the Conway Lake Point Remove watershed meeting. The meetings focus was to continue to work on getting an approved EPA watershed plan. This would allow the watershed group to apply for EPA 319h grants.

The BMP coordinator represented AFC and provided reports at the quarterly AFA Forest Practices Committee meeting.

The BMP coordinator continues to work with the Southeastern Partnership for Forests and Water Forum. The committee is considering next steps for landowner workshops.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA completed 64 plots during the month of April. Inventory 2018 is now 10% complete.
