29	19-1-101. Contracts paid for with public funds.	
30	(a) As used in this section, "public funds" means funds, moneys,	
31	receivables, grants, investments, instruments, real or personal property,	or
32	other assets, liabilities, equities, revenues, receipts, or disbursements,	-
33	belonging to, held by, or passed through:	
34	(1) The State of Arkansas;	

1	(2) A department, agency, division, office, institution of
2	higher education, board, commission, quasi-public organization, or official
3	of the state;
4	(3) A county, municipality, public school district, quasi-public
5	organization, or district; or
6	(4) An official or office of a county or municipality.
7	(b) An entity that uses public funds to fund a contract, in whole or
8	in part, shall make the contract and all information and records related to
9	the contract available at the request of a member of the General Assembly.
