HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

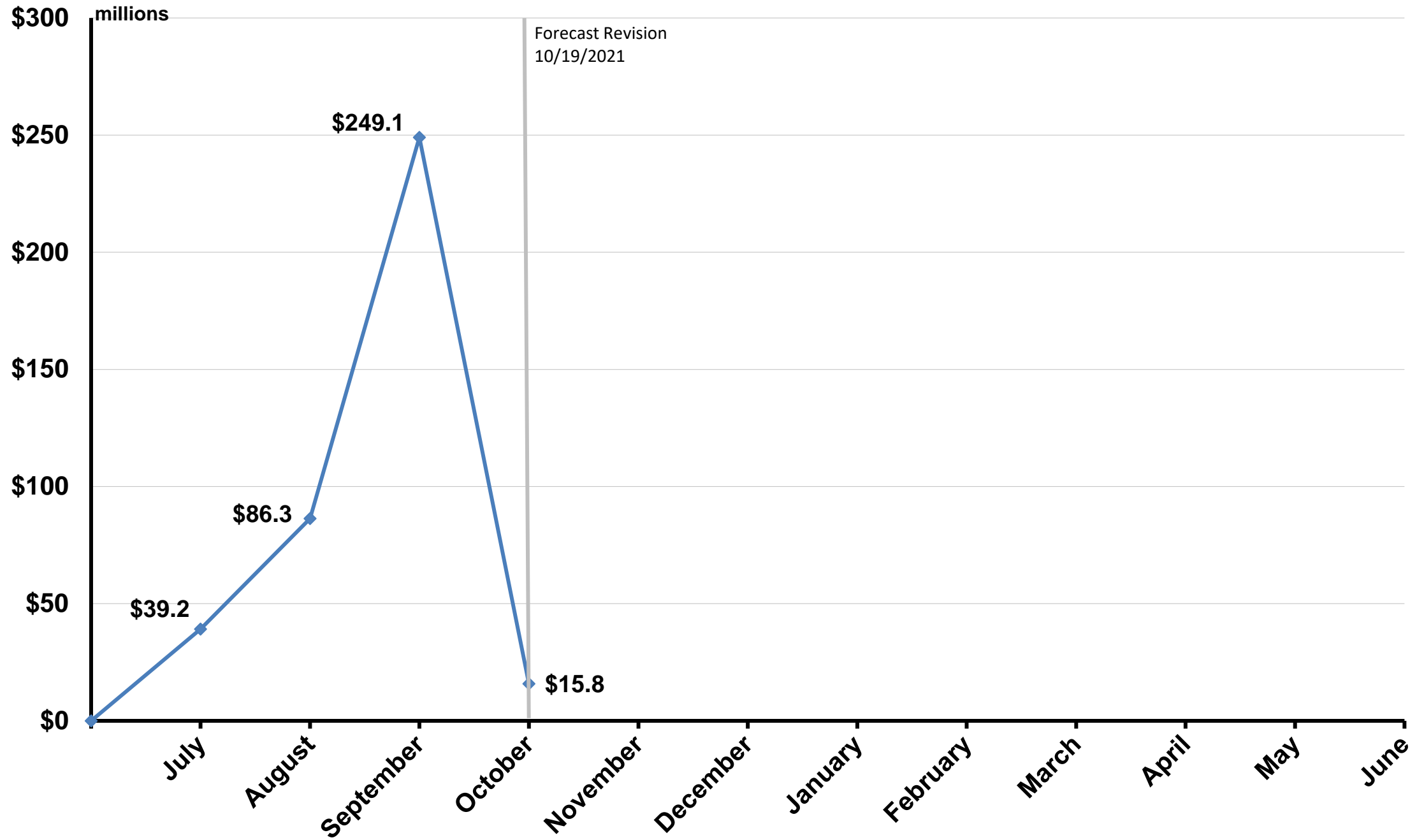

Collections of Gross General Revenues year-to-date of approximately \$2,592.6 million have increased \$25.9 million, or 1.0% above the \$2,566.8 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$548.8 million increased \$62.7 million, or 12.9% from the \$486.1 million available for distribution in October 2020.
