Re: Arkansas Forestry Commission monthly activity report for June 2018

Dear Senator Sample and Representative Dotson:

Per Section 42 of Act 841 of the 2017 Regular Session, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for June 2018.

The Arkansas Forestry Best Management Practices for water quality protection (BMP) Implementation Survey for 2018 is nearing completion. The BMP Coordinator finished all ground surveys, collected data on 237 randomly selected logging sites and completed the analysis of the data. The implementation rate of Arkansas's BMPs has increased from 89% (2011) to 93% (2018).

This increase in implementation of voluntary Forestry Best Management Practices is primarily due to collaboration of partners and the leadership of the recently retired BMP Coordinator (37 years of service to the AFC).

ARKANSAS FORESTRY COMMISSION June 2018 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During June a total of 93 wildfires were suppressed for a total of 1589 acres burned. Ten-year average for the month of June is 79 wildfires for 923 acres burned.

Search and Rescue Assistance: A ranger assisted in a search and found a lady and a 2-year-old child who became stranded on an unmaintained road near Wall Mountain Road, southeast of Kirby in Pike County.

Storm Damage Assistance: Five AFC personnel assisted in storm damage cleanup of tree debris using dozers and chainsaws on roads in the Forest City area in St. Francis County.

An AFC county ranger assisted with clearing tree debris from Highway 25 close to Powhatan in Lawrence County.

Rural Fire Protection: Rural Fire Protection (RFP) assists fire departments (FDs) with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 fire departments. The RFP shop also provides maintenance to AFC equipment.

June 2018

- 24 fire departments, (45 firefighters), were provided wildland fire training.
- RFP received seven freightliners (valued at \$1,163,561.00), one pumper (valued at \$152,697.00), four generators (valued at \$100,292.00), one brush truck (valued at \$48,113.00) and two tool boxes (valued at \$15,315.04)
- There were eight Department of Defense (DOD) vehicles and other equipment issued to FDs including four freightliners (valued at \$474,110.00), three service trucks (valued at \$43,688.56), one brush truck (valued at \$15,313.00) and one boat, with trailer and motor (valued at \$4,093.00).
- 674- DOD Recycling Control Point (RCP) items were received for redistribution to FDs (valued at \$6,581.49) including, spine boards, highway reflector sets and battery chargers.
- The RFP shop completed maintenance on 12 AFC vehicles and five DOD vehicles.
- RFP provided four interest free loans via the Rural Fire Revolving Loan Fund.

- 2017 Wildfire Volunteer Fire (WFVF) Grant update. All items for the grant kits have been received with the exception of the PPE. We are expecting a partial delivery to ship on July 10, with the remaining items shipped on July 17.
- 2018 Annual Fire Show will be held on October 27 from 10:00 a.m. until 2:00 p.m.
 Staff is working on fliers and vendor packets at this time and hope to have them ready to send out by the middle of July.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas is proud to have 167 active Firewise communities. Recognized communities display Firewise signs at the city limits.

Firewise achieved the following in June:

- Assisted one community with renewal paperwork
- Attended three community education events
- Recognized four communities for reaching 15-year Firewise status
- Delivered one initial program presentation
- Attended Arkansas State Firefighter Association Convention

Law Enforcement: AAD has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AAD aggressively seeks prosecution of violators to deter such crimes. AAD Investigators and district law enforcement officers opened ten dumping, six fire related, one equipment theft/ vandalism and ten timber theft cases. They closed ten dumping, three fire related, and 12 timber theft cases.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and\or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,758 landowners owning 869,558 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,299 Forest Stewards owning 280,476 acres.

For June, seven FSP plans were prepared on 484 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 71 rural forestry management plans on 4,920 acres. AFC personnel conducted two prescribed burns on 136 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Staff conducted the following for the month of June:

- Attended Southern Group of State Foresters conference in Richmond, VA
- Prepared FY2018 Urban and Community Forestry grant proposal for US Forest Service
- Participated in AR Municipal League conference in Little Rock by providing information about the AFC and ways that AFC Urban & Community Forestry program can help Arkansas communities. Over 120 contacts with municipal leaders from across the state were made.
- Provided Urban & Community Forestry training to 18 AFC staff. Some of the topics covered
 included the social and economic benefits of trees in communities, the AFC's role in urban &
 community forestry across the state, urban tree care and management, and urban tree pests and
 diseases.
- Attended Urban Forest Strike Team (UFST) training in Houston, TX. The UFST is a group of
 professional arborists who provide disaster planning assistance, risk assessment, and FEMA
 Public Assistance (PA) information to communities following natural disasters.

Forest Health: The Forest Health Specialist assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

Consistent rainfall earlier this year prevented the resurgence of pine bark beetles in Arkansas. However, late June heat and sparse rainfall, which should continue in July and August, may cause problems. Southwestern Arkansas is currently experiencing moderate drought conditions, and it will be especially important to monitor pine tree mortality during this time. Visit the droughtmonitor.unl.edu to see where drought is occurring in the U.S.

Reforestation: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

On June 20, Baucum Nursery hosted the Arkansas Farm Bureau Forestry Committee Meeting. As a part of the committee meeting staff conducted a tour of the nursery for the 18 members in attendance.

On June 26, AFC Reforestation Manager hosted a Tree Improvement Delegation from China. On the morning agenda was the Director of the Western Gulf Forest Tree Improvement Program, Dr. Fred Raley. Dr. Raley presented the history of hardwood tree improvement and principles of improved hardwood orchard establishment in conjunction with a tour of AFC improved hardwood orchards and cherrybark oak progeny tests at the Baucum Nursery location. The afternoon session was led by U of A Asst. Professor of Forestry, Dr Kyle Cunningham, with a field trip to the U of A Cooperative Extension Service Pine Tree Experiment Station. Dr. Cunningham presented his hardwood silvicultural research projects which he is conducting at the experiment station. We ended the day with a tour of a hardwood sawmill in Clarendon.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Baucum Nursery staff completed the following during the month of June

• Planted the following seed.

- After planting, any exposed hardwood seed was covered and a roller was used to reshape the bed.
- The following herbicides were applied
 - o Goaltender and Poast were applied over the top to pine crop, 6 weeks after germination.
 - o Mixture of Shureguard, Oxystar 2E and Roundup were applied to bare ground after planting of all hardwood in field 3 and part of field 2
 - o Poast was applied over the top of all hardwoods in fields 4, 7 and 8.
 - o Roundup was applied on all riser lines and ends of all beds.
- Fertilizer applied as follows
 - o Ammonium sulfate in fields 4, 7 and 8
 - o All pine received 24-0-11 slow release fertilizer (5 to 6-month formulation)
 - o Hardwood in field 2 received 24-0-11 slow release fertilizer (5 to 6-month formulation)
- Pulled weeds by hand in all fields as needed.
- Final seedling sales distribution is listed in the table below.
 - o Total hardwood distribution for F18 was 5,074,300 compared with 5,061,700 in FY17
 - o Total pine distribution for FY18 was 1,378,700 compared with 2,367,855 in FY17

Tree Improvement:

On June 7, Reforestation Manger collected survival data for 960 seedlings which make up a hardwood study on Commissioner Rob Parkes property in Scottsville, AR. This test compares Improved Nuttall Oak with woods run Nuttall Oak; Improved Cherrybark Oak with woods run Cherrybark Oak and a general comparison between the two species on a site that would traditionally be considered low for Cherrybark Oak.

During the month of June, the Bluff City Tree Improvement staff completed the following.

- Changed four hydraulic ports on 6320 John Deer tractor.
- Changed hydraulic filters and fluid on 4320 John Deer tractor.
- Took front two gangs off of timberland disk for repairs.
- Finished spraying Dr. Parkes test site.
- Bush hogged Rosston test.
- Bush hogged block plots at 1703 orchard site.

- Weeded in and around greenhouses.
- Lime was applied to all orchards as prescribed by soil test recommendation.
- Fertilized orchards 1720 and 1721 with 2 oz. each of urea and 13-13-13 per tree.
- Daily fertilization of 3 star containerized seedlings with liquid fertilizer.
- Aerial application of Imidan insecticide was applied to all production orchards.
- Sprayed Rosston test and block plots at 1703 orchard site with herbicides. (Round-up, Arsenal, Oust).
- Completed dozer work at Hope test site.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

The BMP Coordinator provided logistics to the AFA and County Forester Kenny Smothers for a landowner workshop to be held September 11, 2018 at the U of A Experiment Station in Batesville Arkansas. The workshop will be held from 8:30 till 1:00 pm and will have three stops: Hardwood timber harvesting, Prescribed Burning, and Forest Sustainability after a Finial Harvest. Information on protection of water quality with BMP's and cost share programs available for landowners will be some additional information provided at each stop lunch will be included.

The BMP Implementation Survey update, BMP Coordinator finished the ground surveys, collecting data on 237 randomly selected logging sites and completed analysis the data collection.

The BMP coordinator represented AFC at the Southern Group State Foresters Water Resource Committee in Richmond, Virginia. The water committee meeting covered research update and future funding, GIS update on BMP monitoring site selection, working projects that would overlap with the Urban Forestry Committee and how to partner with that group. There was discussion on developing success stories on the Forest and Drinking Water Utility Watersheds. We looked at Federal water policy items, Waters of the United Sates (WOTUS), drafted bullet points for Governors response to EPA, discussed individual state reports and updated the Water Resource Committee work plan.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA completed 82 plots for the month of June. We are 27% complete with Inventory 2018.
