Collections of Gross General Revenues year-to-date of approximately \$2,664.1 million have increased \$121 million, or 4.8%, above the \$2,543.1 million collected last fiscal year-to-date. Net General Revenue Available for distribution this month of \$407.1 million increased \$28.1 million, or 7.4%, from the \$379.0 million available for distribution in November 2017. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,207,773.40 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$11,038,867.00.

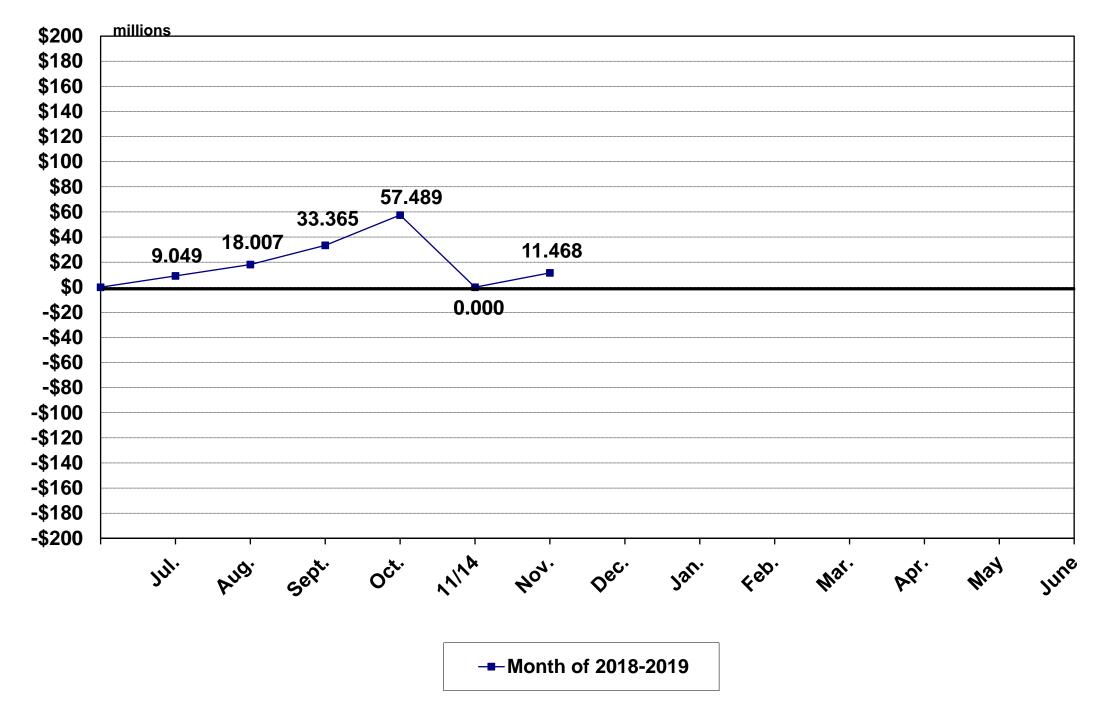
