One property owner applied for (and received) a permit; the other indicated he would apply. Staff is still investigating the remaining four new reports. Staff has continued to work with three other owners on whose properties potential violations were indentified previously, as well as with city officials on one enforcement item. Staff has sent letters to two additional property owners. One owner has not responded. The other responded, but did not indicate a willingness to apply nor correct the potential violations. Staff recommends the Commission consider enforcement action at these properties (bolded below).
