#### Abstract

Collections of Gross General Revenues year-to-date of approximately $\$ 2,741$ million have increased $\$ 97.6$ million, or $3.7 \%$, above the $\$ 2,643.4$ million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of $\$ 418.7$ million increased $\$ 36.9$ million, or $9.7 \%$, from the $\$ 381.8$ million available for distribution in December 2010. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,129,339.71 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of $\$ 12,776,368.26$.
