**Staff received <u>five</u> new reports of potential violations.** Staff has investigated each of these reports, and confirmed <u>four</u> potential violations. Staff contacted each of these four property owners, and two indicated a willingness to correct the potential violation or to apply for a permit. One other indicated they were unwilling to comply with the ordinance, and the final property owner has not replied. Staff has continued to work with four other owners on whose properties potential violations were indentified previously. Staff has sent letters to two additional property owners. One owner has not responded. The other responded, but did not indicate a willingness to comply with the ordinance. Staff recommends the Commission consider enforcement action at these properties (**bolded** below).
