HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$3,294.6 million have increased \$118.7 million, or 3.7%, above the \$3,175.9 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$460.8 million increased \$1.0 million, or .22%, from the \$459.8 million available for distribution in January 2011. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,129,339.71 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$14,905,707.97.

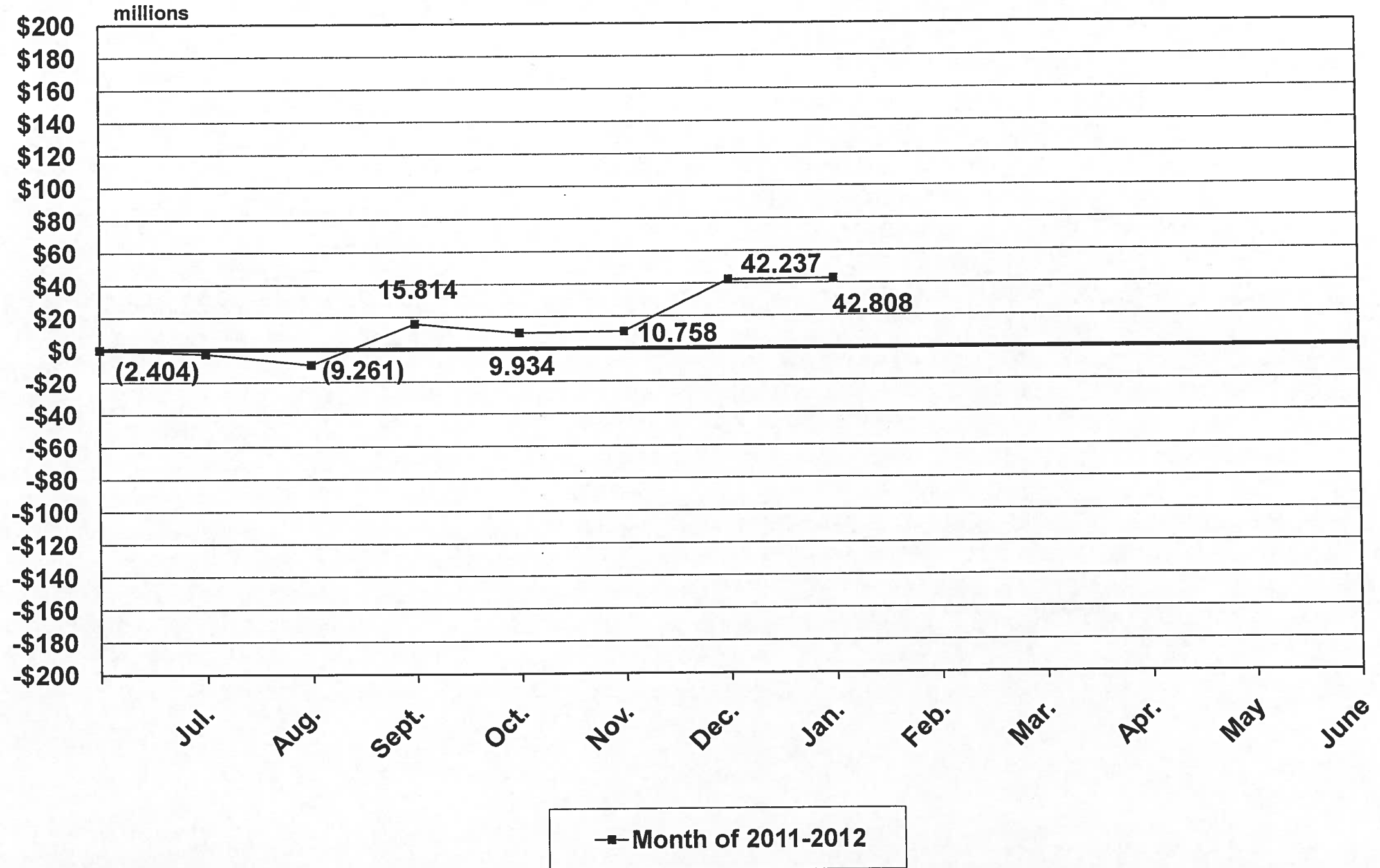
