HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$4,199.6 million have increased \$166.4 million, or 4.1%, above the \$4,033.2 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$356.3 million increased \$40.4 million, or 12.79%, from the \$315.9 million available for distribution in March 2011. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,129,339.71 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$19,164,387.39.

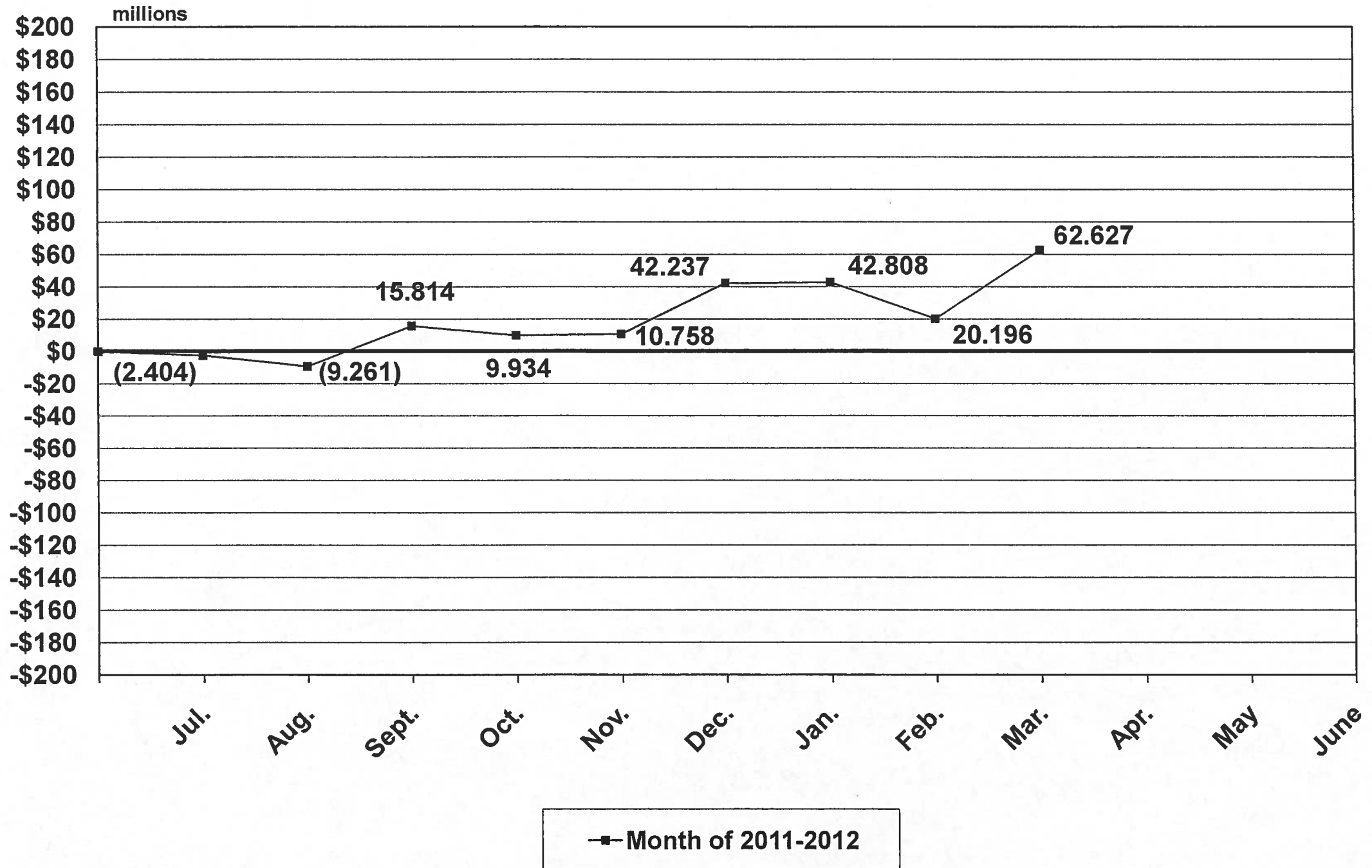
