

Dear Senator Salmon and Representative Baker,

On Tuesday April 3, 2012 an error in the Electronic Offender Management Information System (eOMIS) was discovered. This error resulted in the data for the parole risk assessment tool (PRAT) not being reported in the Board's monthly report. On Friday April 6, 2012 Solomon Graves, APB Administrative Services Manager, met with staff from DCCs IT and Research departments along with a project manager from Marquis (the firm that provides application development for eOMIS). During this meeting it was determined what enhancements were necessary for the Board's monthly report to contain data on the PRAT. It was also agreed that Marquis would begin work on making those changes within eOMIS.

As of today, we have not received an estimate as to when this work will be completed. Mr. Graves will continue to keep your Committee's staff informed as we work to correct this error.

Thanks you for your patience and your continued support of the Board.
