20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code § 24-5-118(a)(2)(A)(i)(d), concerning annuity
23 options under the Arkansas State Highway Employees' Retirement System, is
24 amended to read as follows to correct an internal reference:

25 (d) This subdivision (a)(2)(~~B~~)(~~i~~)(A)(i) ~~shall apply~~ applies to all
26 members and retirants.

28 SECTION 2. Arkansas Code § 24-7-205(c), concerning the correction of
29 errors under the Arkansas Teacher Retirement System, is amended to read as
30 follows to clarify the wording:

31 (c)(1) As used in this subsection, "system action" means A a system-
32 initiated determination, review, administrative action, cause of action, or
33 request to enforce, change, or modify an obligation, duty, benefit
34 calculation, designation, refund, contribution, service credit, or other
35 right arising under this subchapter ~~shall not be valid unless commenced~~
36 ~~within the look back period unless the system determines that the~~

1 ~~justification to commence the process is due to intentional nondisclosure,~~
 2 ~~fraud, misrepresentation, or criminal act.~~

3 (2) Except as provided in subdivision (c)(3) of this section, a
 4 system action must commence within the look-back period, or it is invalid.

5 (3) A system action commenced beyond the look-back period is
 6 valid if the system determines that the system action is justified by
 7 intentional nondisclosure, fraud, misrepresentation, or criminal act.

9 SECTION 3. Arkansas Code § 24-10-102(28), concerning the definition of
 10 "political subdivision" under the Arkansas Local Police and Fire Retirement
 11 System, is amended to read as follows to use the preferred singular noun
 12 form:

13 (28) "Political subdivision" means:

- 14 (A) ~~Incorporated towns~~ An incorporated town;
- 15 (B) ~~Cities~~ A city of the first class;
- 16 (C) ~~Cities~~ A city of the second class;
- 17 (D) ~~Counties~~ A county;
- 18 (E) ~~Fire~~ A fire protection ~~districts~~ district that
- 19 ~~maintain~~ maintains standards established by the board;
- 20 (F) ~~Rural~~ A rural fire protection ~~corporations~~
- 21 corporation; and
- 22 (G) ~~Suburban~~ A suburban improvement ~~districts~~ district;

24 SECTION 4. Arkansas Code § 24-11-213(c)(2), concerning apportionment
 25 of revenues to the Firemen's and Police Officers' Pension and Relief Fund, is
 26 amended to read as follows to correct a reference to a fund:

27 (2) The remaining percentage shall be distributed to the General
 28 Revenue Fund Account of the State Apportionment Fund.

30 SECTION 5. Arkansas Code § 24-11-801(a)(4)(B), concerning the
 31 definition of "member" in relation to the qualifications required for
 32 membership on a board of trustees of a firemen's pension and relief fund, is
 33 amended to read as follows to clarify the wording:

34 (B)~~(i)~~ As used in this section, "member" includes an
 35 active or retired member of the fund-

36 ~~(ii)~~ ~~"Member"~~ but does not include a beneficiary of

1 the fund.

3 SECTION 6. DO NOT CODIFY. The enactment and adoption of this act
4 shall not repeal, expressly or impliedly, the acts passed at the regular
5 session of the Eighty-Ninth General Assembly. All such acts shall have the
6 full force and effect and, so far as those acts intentionally vary from or
7 conflict with any provision contained in this act, those acts shall have the
8 effect of subsequent acts and as amending or repealing the appropriate parts
9 of the Arkansas Code of 1987.
