Collections of Gross General Revenues year-to-date of approximately \$1,275 million have decreased \$109.1 million, or 7.9%, below the \$1,384.1 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$410.3 million decreased \$71.1 million, or 14.8%, from the \$481.4 million available for distribution in September 2008.

In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$1,956,112.71 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$5,868,338.13.
