ARKANSAS FORESTRY COMMISSION July 2012 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During July 2012, an estimated 441 wildfires were suppressed for a total of 7,548 acres burned. On record only July 1952, 1954 and 1980 surpass July 2012 for number of wildfires suppressed and acres burned. Both 1954 and 1980 were record dry summers.

Seventy-five (75) percent of Arkansas is in extreme or exceptional drought. January through June 2012 is the warmest period on record. April through June 2012 is the driest April- June period on record.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments.

Forty-two (42) rural fire departments were provided wildland fire training. Two (2) fire trucks were delivered to rural fire departments. Two (2) fire departments received loans to purchase equipment. Seventeen (17) Department of Defense trucks were picked up from military posts that will be refurbished and provided to fire department for use as fire trucks, brush trucks, or tankers.

FireWise: FireWise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation in certified FireWise communities. Certified communities display FireWise signs at the city limits. FireWise staff assisted 10 communities/fire departments, prepared 10 media releases, made 15 television, radio and newspaper appearances, and provided an educational booth at the annual Arkansas State Firefighters Association and Arkansas Association of Fire Chiefs convention in Hot Springs.

Law Enforcement: Forestry Commission has the authority to enforce the State's laws pertaining to unlawful dumping, timber theft, forest fires, and equipment theft and vandalism. Forestry Commission aggressively seeks prosecution of violators to deter such crimes. In July, Forestry Commission in working with U.S. Attorney Chris Thyer closed a timber theft case that netted the violator 18 months in federal prison, 3 years supervised release, and restitution of \$228,463.80. Forestry Commission worked 1 unlawful dumping and 6 forest fire cases in July.

FOREST MANAGEMENT

Landowner assistance: Forestry Commission foresters prepared 131 forest management plans on 11,436 acres.

Urban forestry assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non- profit organization, developers and homeowners on urban tree care, inventory and management. There are 45 certified Tree City USA communities in Arkansas. Certified communities display Tree City USA signs at the city limits. There are 2 Tree Campus USA (colleges) in Arkansas. In July, Forestry Commission personnel provided technical assistance to 6 communities concerning tree maintenance and Tree City USA program.

Baucum Nursery: Forestry Commission's Baucum Nursery grows hardwood and pine seedlings for reforestation and afforestation efforts. This year's Baucum Nursery inventory consists of 4,855,000 loblolly and shortleaf pine seedlings and 6,793,000 hardwood seedlings of a variety of species.

Best Management Practices: Forestry Commission provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints. During July 2012, one logger training session, three courtesy exams and one logging complaint investigation were performed.

Forest Inventory and Analysis: Forestry Commission in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

For July, FIA personnel have measured 60 plots and completed 3 utilization studies. The FIA Coordinator has provided assistance to 2 forestry companies.

CONSERVATION EDUCATION

Conservation Education programs include presentations to schools and civic organizations, news articles and other media programs. With the loss of Conservation Education staff, the State Forester and other staff conducted multiple radio and television presentations that are not included in the district reporting. During July 2012, the districts reported 42 news articles, 14 radio and television presentations, and 10 presentations to schools or civic organizations.
