Subject:	Alternative Fuel Vehicle Report

This report is provided in accordance with Ark. Code Ann. §19-11-217(2)(A) which requires the Office of State Procurement to develop and implement a plan for all state agencies. The report addresses vehicles acquired that will reduce the overall annual petroleum consumption of state agencies by at least ten percent (10%) by January 1, 2009, through various measures.

This report includes:

- (a) The number and type of alternative-fueled vehicles used by each state agency; *(Attachment A)*
- (b) The difference between the acquisition cost, maintenance, and operation of alternativefueled vehicles and comparable conventionally fueled motor vehicles; *(Attachment B)*
- (c) An evaluation of the plan's success; and
- (d) Suggestions for modifying the plan.

The initial step the Office of State Procurement took was creating a state-wide contract for alternative and hybrid vehicles, beginning with the 2006 model vehicles. Each year since the inception of this contract, it has been modified to increase and encompass the market-available vehicles.

The increased usage of alternative-fueled vehicles is based on continued funding, emphasis on the continued use of hybrid or alternative-fueled vehicles, the availability of competitively priced vehicles and alternative fuels, and the active participation of the state agencies. There continues to be a significant purchase price difference between alternative-fueled vehicles and conventionally fueled vehicles. **Attachment B** is a comparison of acquisition cost, average gas mileage, annual gas costs and savings, based upon an average of \$3.55 per gallon of gasoline. As the market matures so that hybrid and alternative-fueled vehicles increase in availability and prices become more comparable, the margin between petroleum-fueled vehicles and alternative-fueled vehicles should begin to equalize and become more attractive for the state to purchase and use.

Ark. Code Ann. § 15-13-205 required the Department of Finance & Administration to implement a policy regarding the standard of biofuel usage, effective January 1, 2009. The policy states that when available and economically feasible, all State agencies are required to purchase diesel fuel that contains at least a

minimum of two percent (2%) biofuels by volume for all State diesel powered motor vehicles, light trucks and equipment. The average diesel cost in 2012 was \$3.968 per gallon. This policy works in tangent with the requirement to purchase alternative-fueled vehicles to help achieve the 10% goal for the annual reduction of petroleum consumption by state agencies.

As of December 31, 2012, the state had 290 vehicles that fall into the alternative-fueled category. This figure includes those alternative- or hybrid-fueled vehicles purchased from contracts developed and awarded by the Arkansas Highways and Transportation Department. The current percentage of alternative-fuel vehicles is 3.4% of the 8,445 vehicles in the state fleet as of December 31, 2012. The purchase of alternative-fueled vehicles has kept abreast of what the market currently bears relating to the life cycle cost of both types of vehicles. As the market matures where alternative-fueled vehicles and alternative fuels become more widely available in Arkansas, the State's usage could potentially increase.

In 2012, the Office of State Procurement worked with the State of Oklahoma on a cooperative contract for compressed natural gas vehicles. There are now four CNG vehicles available on the state contract: Honda Civic NG, Chevrolet Silverado 2500, Chevrolet Express 2500 & 3500 cargo vans. State Procurement contracted with two Arkansas certified installers to facilitate the CNG conversions for state vehicles. These efforts, along with the opening of the North Little Rock compressed natural gas station, helps to position the state to migrate to vehicles that will reduce the overall annual petroleum consumption. The Office of State Procurement maintains a life-cycle cost comparison chart on state contract vehicles to assist entities in making an informed decision when purchasing a vehicle.

The Office of State Procurement, working with the Arkansas Office of Energy and the Arkansas Department of Environmental Quality, continues to disseminate information necessary to educate agency personnel about alternative fuels, vehicles and their availability in Arkansas.
