Dear Senator Bookout and Representative Edwards:

Per Act 434 of the 2013 General Session, Section 48, the Arkansas Forestry Commission is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for July 2013.

The Arkansas Forestry Commission (AFC) foresters provide forest management assistance and plans for over 800 private non-industrial landowners each year. Driven by the landowner's objectives, AFC's forest management plans provide landowners with recommendations on planting highly erodible croplands, abandoned pastures or reforesting tracts that have been harvested for timber products.

A very important part of Arkansas's tree planting efforts is AFC's Baucum Nursery located east of North Little Rock. This year Baucum Nursery is growing 9.4 million pine and hardwood seedlings. Arkansas's tree planting efforts are important, providing future wood products, wildlife habitat and clean air and water. Through AFC's tree improvement program several of the tree species grown at Baucum Nursery are genetically improved giving landowners greater annual growth per acre.

I am very proud of AFC's work to make Arkansas's forests sustainable, providing economic and recreational opportunities while improving the environment for future generations.

Landowners can view which tree species are available for sale by the AFC and can purchase AFC seedlings through the AFC website- www.arkansasforestry.org.

# ARKANSAS FORESTRY COMMISSION July 2013 Activity and Fiscal Report

### **FIRE PROTECTION**

Wildfires: During July, a total of 113 wildfires were suppressed for a total of 1,090 acres burned. Ten year average for the month of July is 166 fires for 2,231 acres burned.

**Search and Rescue Assistance:** AFC crews assisted in 4 search and rescue operations in Benton and Newton Counties. Three of the search and rescue operations were in Newton County.

**Rural Fire Protection:** Rural Fire Protection (RFP) assists rural volunteer fire departments with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In July, 56 rural fire departments (168 firefighters) were provided wildland fire training. Fourteen Department of Defense (DOD) trucks were picked up from military posts that will be refurbished and provided to fire departments for use as fire trucks, brush trucks, or tankers. 3,060 DOD Recycling Control Point (RCP) firefighter equipment items were issued to rural fire departments such flashlights, safety glasses, gloves, emergency revolving lights, and boots. RFP provided one rural fire department loan through the Revolving Fund for a total of \$13,593.91 (Rocky Point, White County, District 7).

The RFP shop completed maintenance on sixteen AFC vehicles and dozers.

**Firewise:** Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 115 active Firewise communities in 2012. Recognized communities display Firewise signs at the city limits.

In July, Firewise staff assisted 13 communities/fire departments with renewal efforts, conducted 10 initial presentations about the Firewise program, three risk assessment training, conducted two Firewise recognition ceremonies and provided materials for three additional Firewise Day events. Staff attended the Cherry Hill Breakfast and Firewise Day. Staff taught two 8-hour Wildland Firefighting classes.

Firewise staff visited 10 AFC county and district offices to discuss Firewise programs in their area and met with 18 fire chiefs to provide information on Firewise. Staff talked with three county Office of Emergency Management coordinators about Firewise. Staff conducted routine inspections of equipment bought with Firewise grants.

Firewise staff is currently assisting with the Firewise plan revision for Petit Jean State Park.

Firewise staff prepared five media releases, provided 5 interviews to the news media, responded to 20 media calls about fire prevention and fire danger, and collaborated with U.S. Forest Service on a news release. Staff updated the Firewise Website and Facebook Page.

Law Enforcement: Forestry Commission has the authority to enforce the State's laws pertaining to unlawful dumping, timber theft, forest fires, and equipment theft and vandalism. Forestry Commission aggressively seeks prosecution of violators to deter such crimes. In June, AFC Investigators and district law enforcement officers worked 7 fire related, 6 unlawful dumping, and 8 timber theft cases.

AFC Investigators did a presentation at the University of Arkansas at Monticello for an Arkansas Forestry Association teacher's workshop. AFC Investigators conducted a methamphetamine awareness class for Green Bay Packaging field employees.

#### **FOREST MANAGEMENT**

Forest Stewardship/Rural Forestry Assistance Programs: The AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for a non-industrial private forest landowner interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry, aesthetics, and/or timber production to have a comprehensive multiple use forest management plan prepared. Private consulting or AFC foresters working in conjunction with private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals collaboratively develop the multi-resource management plan for the landowner.

Arkansas has 4,599 landowners owning 846,338 acres enrolled in the FSP. For July, 19 FSP plans were prepared on 1,897 acres. Landowners that implement practices under their FSP management plans become certified Forest Stewards. In July, 6 landowners owning 1,484 acres were certified as Forest Stewards. Arkansas has 1,258 active Forest Stewards owning 284,391 acres.

In addition to the FSP, AFC personnel provide technical assistance through the rural forestry program to landowners enrolled in USDA tree planting and forest management programs such as: the Conservation Reserve Program, Environmental Quality Incentives Program, and Wetland Reserve Program. For July, AFC foresters prepared 37 rural forestry program forest management plans on 1,579 acres. In addition, AFC personnel constructed 65,453 feet of fire lanes and conducted 4 prescribed burns on 89 acres.

**Forest Health:** AFC offers cost-share incentives to landowners for thinning and restoration work in pine stands as part of a comprehensive federal Southern Pine Beetle (SPB) Prevention Program. This program is well-received by landowners. For July, 11 projects on 524 acres were completed.

Concerns with dying or declining oak trees in northwest and north central Arkansas continued to be reported. Respective County Foresters are checking with the landowners to identify problems. The oak decline is due in part to the three drought years (2010-2012).

During July detection flights for Southern Pine Beetle (SPB) were conducted in eight counties (Ashley, Drew, Bradley, Cleveland, Lincoln, Columbia, Hempstead, and north half of Union) with no SPB detected.

**Urban forestry assistance:** Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

An urban forestry grant in the amount of \$2,500 was awarded to the Fayetteville Natural Heritage Association (FNHA) to help fund a research project atop Mount Kessler by a University of Arkansas graduate student to help promote the land as an outdoor laboratory. A master's degree candidate in the geosciences department is working to catalog old-growth trees in two rugged glades on the wooded hillside in southwest Fayetteville. He is using a Swedish increment borer to take core samples from about 125 post oak trees at one study site at Mount Kessler. The less than pencil-width samples are taken to the university's tree-ring laboratory, where they'll be mounted, polished and studied under a microscope.

The project is a continuation from the partnership that the AFC formed with FNHA in 2005 with a grant to identify the highest priority natural areas for conservation in and around Fayetteville. Partners included The Nature Conservancy's Ozark Highlands Office, the Landscape Architecture Department at the University and the Beaver Water District. The City of Fayetteville adopted the assessment as part of their 2025 plan.

Through participation of the Strategic Conservation Training Program, the AFC and the Beaver Water District recognized an opportunity to initiate a Green Infrastructure Plan for Northwest Arkansas to address the rapid land use changes occurring with strategic conservation planning. AFC applied for and received a grant from the USFS in the amount of \$25,000 and then awarded the \$2,500 grant to the FNHA.

The FNHA received the National Green Infrastructure Implementation Award for the Green Infrastructure Plan. The success of the Green Infrastructure Plan demonstrated the collaboration process that was implemented among key partners and local officials and the invaluable public input provided through volunteerism and professional recommendations. In addition they received awards for their work from the Arbor Day Foundation and the Home Depot Foundation at the National Urban Forestry Conference in Baltimore.

**Baucum Nursery:** AFC's Baucum Nursery grows hardwood and pine seedlings for reforestation and afforestation efforts. For the 2013-2014 season the target number for pine is 4,105,000 seedlings and hardwood is 5,350,000 seedlings.

During this time of year Baucum Nursery personnel are busy keeping weeds out of the beds and providing all the necessary water, fertilizer and pesticides. Seedlings are growing well with the mild summer and above average levels of rainfall. As a result, the beds of seedlings are being top pruned to keep height and diameter uniform.

**Tree Improvement:** AFC's tree improvement program provides landowners with the highest possible genetic gain in pine and hardwood seed. One of AFC's objectives in tree improvement is establishing the highest genetic gain material in our newest seed orchards. AFC Baucum Nursery makes available to landowners the improved varieties of pine and hardwood.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

During July, the BMP coordinator conducted one technical logger training session and one courtesy exam.

BMP Coordinator is working with the Arkansas Timber Producers Association planning committee for the Southwest Forest Products Expo to be held August 23-24, 2013 at Hot Springs.

BMP coordinator is providing onsite supervision for the Central Arkansas Water BMP fire break/roads project. As of July, the AFC has completed Phase 1 of the CAW project. BMP Coordinator continues to work on the USDA Forest Service competitive grant that will provide funds for AFC to design and implement a BMP demonstration area on the Poison Springs State Forest.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

For July, FIA personnel have measured and submitted data on 70 plots.

### **CONSERVATION EDUCATION**

Conservation Education programs include presentations to schools and civic organizations, news articles and other media programs. With the loss of Conservation Education staff, the State Forester and other staff conducted media and civic organization presentations that are not included in the district reporting. During July, the districts reported 24 news articles, 11 presentations to schools or civic organizations, one tree planting events with communities or schools and three exhibits at public events.
