# SUBCOMMITTEE ON PERFORMANCE EVALUATION AND EXPENDITURE REVIEW (PEER) OF THE ARKANSAS LEGISLATIVE COUNCIL

#### November 15, 2013

#### Co-Chairs:

Your Subcommittee on Performance Evaluation and Expenditure Review (PEER) met on November 7, 2013, and after having reviewed the following items, reports that the Subcommittee's review and/or approval is complete.
