HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$3,487.9 million have increased \$72 million, or 2.1%, above the \$3,415.9 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$483.6 million decreased \$32.5 million, or 6.3%, from the \$516.1 million available for distribution in January 2013. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,276,239.83 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$15,933,678.81.


