The Design Review Committee, Mansion Advisory Committee, and the Commission met in March. Committee members contributed **approximately 61 hours of volunteer service** to the agency. Four undergraduate interns from University of Central Arkansas began an architectural survey of properties along Third and Dennison Streets for possible future historic districts. Director Maher represented the agency at a meeting of the Quapaw Quarter Association's Historic Marker Committee.
