**HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS**

Collections of Gross General Revenues year-to-date of approximately \$5,635.5 million have increased \$33.4 million, or 0.6%, above the \$5,602.1 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$315.4 million decreased \$18.9 million, or 5.6%, from the \$334.2 million available for distribution in May 2013. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,276,239.83 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$25,038,638.13.


