HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$6,252.7 million have increased \$28.6 million, or 0.5%, above the \$6,224.1 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$539 million decreased \$7.9 million, or 1.5%, from the \$546.9 million available for distribution in June 2013. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,276,239.79 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$27,314,877.92.

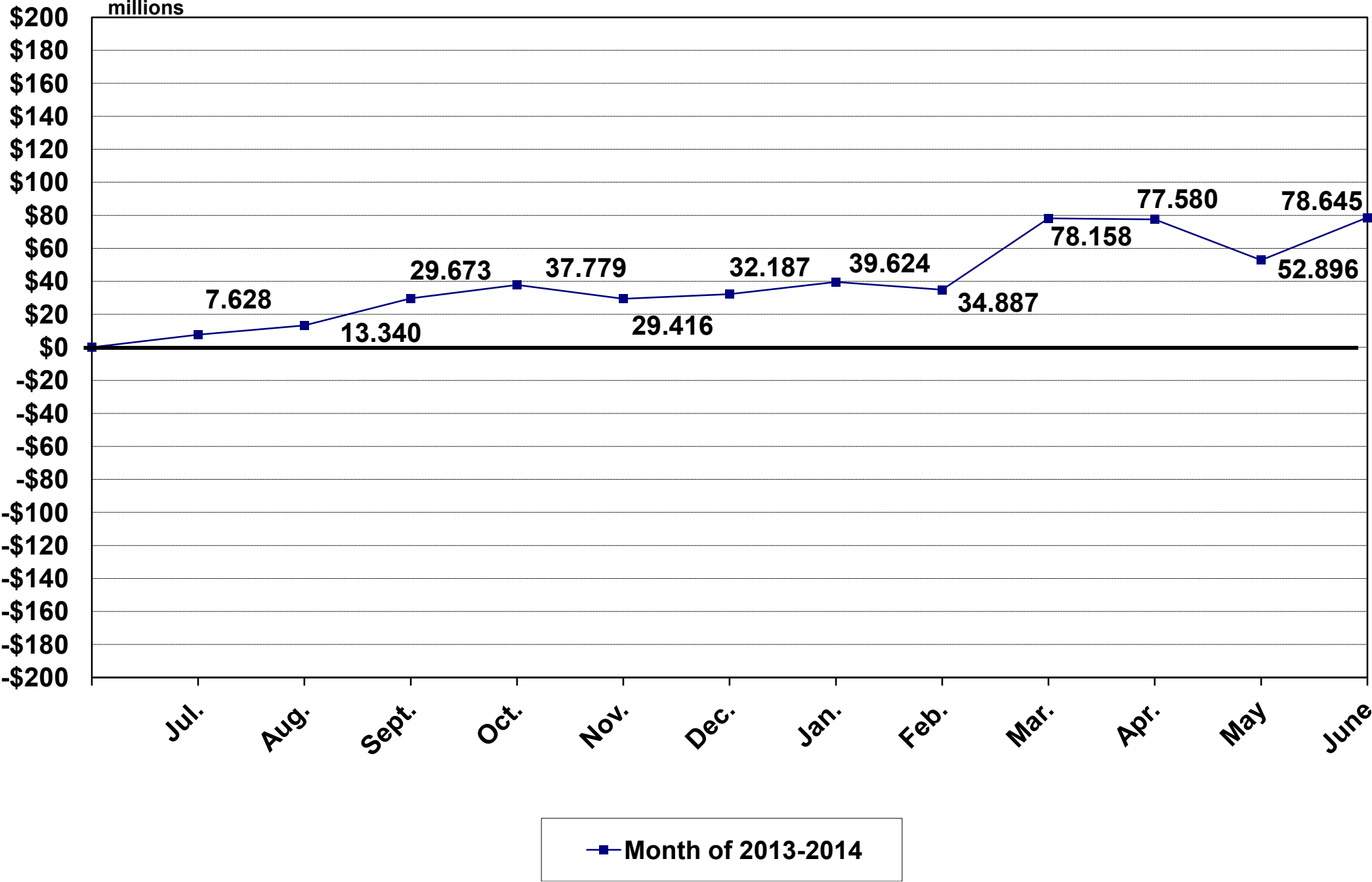
