State of Arkansas ex rel. Dustin McDaniel v. GlaxoSmithKline, Case No. 60CV-14-2142 (Pulaski County, Arkansas-6<sup>th</sup> Division). \$1,518,083.14 recovered this quarter. Counsel for the Attorney General's Office negotiated and jointly drafted this agreement with other State Attorneys General and with opposing counsel. Once all sides agreed to specific language in the document it was submitted to the Court for review and approval.

State of Arkansas ex rel. Dustin McDaniel v. National Police Defense Foundation, et al., Case No. 60CV-134-2741(Pulaski County, Arkansas-5<sup>th</sup> Division); \$120,000 recovered this quarter. Counsel for the Attorney General's Office negotiated and jointly drafted this agreement with opposing counsel. Once all sides agreed to specific language in the document it was submitted to the Court for review and approval.

State of Arkansas ex rel. Dustin McDaniel v. Wyeth Pharmaceuticals, Inc., Case No. 60CV-14-3041 (Pulaski County, Arkansas-12<sup>th</sup> Division). \$530,785.11 recovered this quarter. Counsel for the Attorney General's Office negotiated and jointly drafted this agreement with other State Attorneys General and with opposing counsel. Once all sides agreed to specific language in the document it was submitted to the Court for review and approval.

#### Rationale for Expenditures

- -The distributions for "Office Renovation Expenses" relate to the Attorney General's lease obligation and renovations pursuant to that lease obligation. The funds used to support these expenditures were from recoveries obtained in consumer protection cases. There is no specific mention of the Attorney General's lease obligation in the relevant orders and agreements.
- The distributions that relate to "Got Your Back Arkansas" have been expended pursuant to the authority and obligation of the Consumer Protection Division to "promote consumer education" and "enforce" the provisions of the Arkansas Deceptive Trade Practices Act (Ark. Code Ann. §4-88-101 et seq.). The funds that were used to support these cases were from recoveries obtained in other consumer protection cases. There is no specific mention of "Got Your Back Arkansas" in the relevant orders.
