Re: Arkansas Forestry Commission monthly activity report for October 2014

Dear Senator Sample and Representative Edwards:

Per Act 434 of the 89th General Assembly, Section 48, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for October 2014.

Rural volunteer fire departments (VFDs) are important partners of the AFC in our wildfire prevention and suppression efforts. The last Saturday in October, the AFC recognized that great partnership by hosting the annual Fire Fighter Appreciation Fire Show at the AFC Greenbrier Rural Fire Protection facility. Over 100 fire departments were represented.

The periodic rains in October helped reduce the wild fire danger and occurrence. After one storm event that caused damage primarily in south Arkansas, AFC crews assisted with clearing roads. AFC flew the storm path and notified affected forest landowners of timber damage on their property.

ARKANSAS FORESTRY COMMISSION October 2014 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During October, a total of 17 wildfires were suppressed for a total of 61 acres burned. Ten year average for the month of October is 97 wildfires for 1,182 acres burned.

Search and Rescue Assistance: An AFC crew from Newton County assisted in a search and rescue operation for a missing child on the Buffalo National River. Also, an AFC crew assisted in a search and rescue operation for a missing child east of Stuttgart in Arkansas County.

Storm Damage Assistance: AFC crews assisted in clearing roads from trees that fell across them during a storm on October 13th. The roads that the AFC crews helped clear were located in Grant, Pike, Polk, and Sevier Counties.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In October, 51 rural fire departments (133 firefighters) were provided Wildland fire training. There were 5 Department of Defense (DOD) trucks (valued at \$519,893.00) picked up from military posts. 868 DOD Recycling Control Point (RCP) items (valued at \$411,664.61) were received for redistribution to VFD's such as tires, navigational lights, searchlights with remote control, spill kits and nozzles.

Rural Fire provided 1 interest free loan through the AFC Rural Fire Revolving Loan Fund for Chimes VFD (Van Buren County) for a 2004 Ford F350 - \$9,900.00.

The RFP shop completed maintenance on eight AFC vehicles and dozers.

The AFC Rural Fire Protection Annual Fire Fighter Appreciation Fire Show was held on Saturday, October 25, with approximately 350 people in attendance and 107 fire departments represented.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 139 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In October, Firewise staff assisted 75 communities/fire departments with Firewise renewal efforts, assisted three communities (Fairfield Bay, Hot Springs Village, and Antioch) with a Community Wildfire Protection Plan, conducted seven initial presentations about the Firewise program, and presented three

risk assessment trainings. Firewise staff attended the Bradley Firewise Day and assisted Cherry Hill with their Firewise mitigation project.

Firewise staff visited 14 AFC county and district offices to discuss Firewise programs in their area and met with 33 fire chiefs to provide information on Firewise. Firewise staff talked with five county Office of Emergency Management coordinators about Firewise. Firewise staff provided educational material for 10 Firewise events and attended the annual rural fire show at Greenbrier. Firewise staff attended the webinar on Southwrap and seminar on Improving Access for Wildland Firefighters.

Firewise staff assisted with 20 media releases and updated Facebook site and www.arkansasfirewise.com. Firewise staff attended fire fighter training to fill single engine air tankers (SEATs) and the AFC Red Card Committee meeting.

Firewise consulted with Clinton EAST program and the Girl Scouts Firewise patch program.

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In October, AFC Investigators and district law enforcement officers opened 6 dumping, 1 fire related and 11 timber theft cases.

AFC law enforcement officer personnel patrolled Poison Springs State Forest camp sites during deer muzzle loading season and assisted with the annual rural fire show in Greenbrier.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,670 landowners owning 858,521 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,308 Forest Stewards owning 282,145 acres.

For October, 7 FSP plans were prepared on 360 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 89 rural forestry management plans on 5,920 acres. AFC personnel constructed 133,292 feet of fire lane. AFC personnel conducted 14 prescribed burns on 663 acres.

Forest Health: Emerald ash borer was not reported in any new counties in October. The emergency quarantine established by the State Plant Board will expire in December and a public meeting is scheduled for December 18 to review the proposed permanent quarantine regulations.

A single gypsy moth was identified in a pheromone trap from Nevada County. As this discovery is still recent, further detection and regulation are forthcoming. The insect, an invasive species introduced in Maine from China in 1869, has spread by natural and human-influenced dispersal across the entire eastern

United States. It poses a serious threat to Arkansas's hardwood forests. Control of a major outbreak in northern Arkansas during the 1990s was a success.

The invasive redbay ambrosia beetle and the associated laurel wilt disease were discovered 5-6 miles from the Arkansas border in Union Parish in Louisiana. It was also discovered in Claiborne and Lincoln Parishes. In Arkansas, this disease and its beetle vector can kill sassafras trees. With a sparse distribution of sassafras, it is uncertain how this disease will affect Arkansas forests.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales for FY15 began on July 15. Sales through the end of October are 624,100 pine; 495,000 oak and 608,300 other hardwood.

Baucum Nursery crew continues to provide necessary cultural practices to the pine and hardwood crops; especially top pruning, fertilization, irrigation and hand weeding. Field inventory in the nursery beds is being conducted at this time.

Assistant State Forester- Resource Management and Reforestation Manager conducted a tree seedling workshop at Ferncliff. There were 60 AFC and USDA Natural Resource Conservation Service employees in attendance. The agenda included 4 speakers covering a wide range of seedling care and planting information. The key note speaker was Dr. Tom Starkey from Auburn University.

AFC personnel conducted a tour of Baucum Nursery with Dr. Tom Starkey and Barry Brooks, both from Auburn University.

Reforestation Manager worked with photographer and writer for an article about AFC seedling production for the Arkansas Grown annual publication.

Tree Improvement: AFC's tree improvement program provides landowners with the highest possible genetic gain in pine and hardwood seed. One of AFC's objectives in tree improvement is establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery makes available to landowners the improved varieties of pine and hardwood, which is the result of the tree improvement program.

Cone harvest is almost complete. The contract crew is currently harvesting our shortleaf pine cones. A report for the total loblolly and shortleaf cone harvest will be available in November.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

The BMP coordinator responded to four complaints on logging operations. Of the four, only one in Izard County was valid. The complaint involved water quality impairment problems with a Streamside Management Zone.

The BMP coordinator provided one technical logger training session in Idabel, Oklahoma for International Paper and Weyerhaeuser Company foresters, loggers and contractors. The training was attended by approximately 50 participants.

The BMP coordinator represented AFC and provided reports at the BMP Task Force Committee meeting.

The BMP coordinator participated by speaking and providing handouts at the Arkansas Forestry Association's landowner tour of Tree Farmer of the Year John L. McClellan's property. The event was attended by approximately 60 participants.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

For October, FIA personnel have measured and submitted data on 80 plots.
