Re: Arkansas Forestry Commission monthly activity report for July, 2015

Dear Senator Sample and Representative Branscum:

Per Act 890 of the 90th General Assembly, Regular Session, 2015, Section 47, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for July, 2015.

Urban Forestry staff worked with the City of Batesville to update a tree inventory for the downtown area. The city's goal is to revitalize this area and plan for the planting and placement of new trees. Batesville's tree inventory was to help them better manage and assign an economic value to the trees throughout the city. Trees were identified for removal and pruning to improve the safety of the public areas.

Using the I-Tree program, it was calculated that 2,100 pounds of carbon are sequestered each year by the trees inside Batesville. The inventory also examined species diversity and it was determined that crape myrtle makes up 65% of the tree canopy. Batesville now has the information needed to improve their tree canopy and implement an improved urban forest management program.

ARKANSAS FORESTRY COMMISSION July 2015 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During July, a total of 33 wildfires were suppressed with a total of 126 acres burned. Ten year average for the month of July is 157 wildfires with 2,157 acres burned.

Search and Rescue Assistance: An AFC crew consisting of two rangers and a forester from Newton County, a ranger from Carroll County, and a ranger from Benton County assisted in a search and rescue operation for an elderly woman around Witt Springs in Searcy County. She was found safe.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In July 2015, 37 rural fire departments (99 firefighters) were provided wildland fire training. RFP received 12 Freightliners and 1 Chevrolet from Department of Defense (DOD) (valued at \$1,006,042.60). There were 10 Department of Defense (DOD) vehicles and 1 generator (valued at \$826,713.00) issued to VFDs. One thousand eight hundred ninety six (1,896) DOD Recycling Control Point (RCP) items (\$227,658.10) were received for redistribution to VFD's such as spill kits, axes, and hydraulic jacks.

Rural Fire provided 2 interest free loans via the Rural Fire Revolving Loan Fund in July 2015.

The RFP shop completed maintenance on eleven AFC vehicles and equipment.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 145 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In July Firewise staff assisted 24 communities with Firewise renewal efforts, conducted four initial presentations about the Firewise program, and presented five risk assessment trainings. Firewise staff attended the EMS conference, Southwrap training, and local VFD board meetings.

Staff assisted with four Firewise education open houses and four mitigation projects. Firewise staff visited 22 AFC county and district offices to discuss Firewise programs in their area and met with 32 fire chiefs to provide information on Firewise. Firewise staff met with 10 county Office of Emergency Management coordinators about Firewise. Firewise staff provided educational material

for 20 Firewise events. Firewise staff created four media releases and conducted a recognition ceremony for Mt. Nebo.

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In May, AFC Investigators and district law enforcement officers opened 6 timber theft cases.

Two AFC law enforcement officers gave a law enforcement presentation at a Green Bay logger training. AFC law enforcement officers conducted the county ranger annual law enforcement training for Districts 1, 2, and 4 this month.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agroforestry and\or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,779 landowners owning 877,903 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,300 Forest Stewards owning 280,385 acres.

For July, 11 FSP plans were prepared on 2,748 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 53 rural forestry management plans on 9,498 acres. AFC personnel conducted 5 prescribed burn on 62 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Urban Forestry staff worked with the urban representative and county rangers to implement a tree inventory for the downtown area of Batesville. The City's goal is to revitalize this area which includes the planting of trees. The existing tree inventory was updated for tree condition as well as including species selection for new proposed plantings. Staff also added Main Street and a city owned cemetery to the tree inventory to help them better manage the trees they have throughout the city. Trees were identified for removal and pruning to improve the safety of the public areas. The inventory was able to also give values for the trees. Using the i-Tree program the trees were quantified and it was calculated that 2,100 pounds of carbon is sequestered each year. The inventory looked at species diversity and the community definitely has a challenge as it was determined that Crape myrtle makes up 65% of the tree canopy. Batesville now has the information needed to improve their tree canopy and implement an improved management program.

Forest Health: As of July 1st, three counties have been added to the list of EAB detected counties: Union, Calhoun, and Bradley. These detections do not change the quarantine region. However, traps that were set up earlier this year outside of the quarantine will be checked later this summer, and detection in these traps could warrant a quarantine boundary change.

The Southern Forest Insect Work Conference was held in Fayetteville. This conference serves as the one of the most important annual meetings of forest health professionals in the southeastern U.S. AFC Forest Health Specialist, Chandler Barton, led a discussion on emerald ash borer in the south.

As we enter the second half of summer, a period of dry weather conditions, it will be important to watch for evidence of *Ips* beetles in pine trees. Pine forests that were subjected to saturated soils this spring may be more vulnerable to attack in subsequent dry periods. Ips damages have been minimal the past couple of years, but like most native pests, their effects occur periodically, and land managers must be conscious of their presence.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15. Through the end of July there were 52 on line seedling orders. Seedling sales reports for FY16 will begin in August. A recap of FY15 seedling sales by cooler location is listed in the chart below. The chart includes volume of hardwood and pine seedlings sold by cooler location for FY14, FY15 and the variance between the two years.

Reforestation Manager and Nursery Manager attended the Auburn Nursery Coop (Southern Forest Nursery Management Cooperative) annual contact meeting. This year the meeting was held on St. Simons Island GA in conjunction with the Auburn University Forest Health Cooperative. There were about 50 forestry professionals in attendance for presentations and research reports on nursery management and forest health issues. The meeting covers three days with one day dedicated to a field trip. The field trip this year was to Plum Creek Jessup Nursery and Seed Orchard along with a silvicultural trial comparing various herbicide applications and bedding treatments.

As a result of very wet spring planting season there has been an unusual problem with weeds in the nursery beds. A combination of AFC labor from both Baucum and Bluff City along with temp service contract labor for weed removal spent most of July hand weeding. Proper herbicides have also been applied in all possible cases.

Tree Improvement: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

Tree Improvement staff installed the drip irrigation system for two new orchards; the improved shortleaf orchard #1720 and a new breeding orchard #1721. The staff also spent time during July hand weeding in the greenhouse and hand weeding containers growing outside the greenhouse. All orchards were bush hogged. Drilling of cores in two progeny tests in Columbia County began. This is a tedious and very time consuming job where an increment borer is used at about 2 feet from ground level to drill a core through the center of the tree. There are over 1,000 trees in each test and every tree in each of the two tests will be sampled for specific gravity; which is a measure of wood density. We use the trees with high specific gravity to help with the selection process of future breeding.

Best Management Practices (BMP): AFC provides BMP training to loggers and timber companies; conducts courtesy exams prior to beginning, or during timber harvest operations; and, addresses logging complaints.

The BMP Coordinator conducted one courtesy exam in Jefferson County with 4 participants. The exam compared the Arkansas Forestry Commissions BMP Program to the harvest site. The BMP coordinator provided an overview of the entire program and offered technical assistance and training to help with the landowner's SFI program and audits.

The BMP Coordinator received one timber harvesting complaint in Lincoln County. After a field inspection, the complaint was found to be a construction site and not a forest site.

The BMP coordinator continues to work with the Southeastern Partnership for Forests and Water Forum. The committee had a conference call meeting and agreed to move forward first with a joint public service announcement on the connection between forest and drinking water and the importance of healthy forests and water. We will continue to meet monthly to complete this assignment.

The BMP coordinator worked with the Southern Group State Foresters (SGSF) Water Resources Committee and came up with concerns of potential impacts from the 300 page finale rule of the Waters of The United States (WOTUS) from EPA and USACE. The SGSF summited a comment letter to Gina McCarthy Administrator of the EPA, addressing their concerns and seeking clarification around a number of elements of the final Clean Water Rule.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

For July, FIA personnel have measured and submitted data on 71 plots.
