Dear Senator Sample and Representative Branscum:

Per Act 59 of the 89<sup>th</sup> General Assembly, Fiscal Session, 2014, Section 48, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for November 2015.

In November, rainfall was abundant statewide. With the rainfall, wildfire danger and activities were quite low. During times of low wildfire danger field staff can work on other activities such as: perform regular maintenance on firefighting equipment and work center buildings, conduct wildfire prevention programs for schools and community groups, follow-up with private landowners for forest planning purposes, and many other things.

Even when Arkansas is not having fires the AFC is preparing for our next fire season and working with Arkansas forest landowners to plan for their healthy and productive forests.

# ARKANSAS FORESTRY COMMISSION November 2015 Activity and Fiscal Report

#### **FIRE PROTECTION**

**Wildfires:** During November a total of 19 wildfires were suppressed for a total of 196 acres burned. Ten year average for the month of November is 69 wildfires for 1078 acres burned.

**Storm Damage Assistance:** Two AFC rangers from Montgomery County cut up a tree and removed it from Fair Grounds Road. The tree had fallen across a power line and into the road because of high winds and the saturated ground from rain.

**Rural Fire Protection:** Rural Fire Protection (RFP) assists rural volunteer fire departments with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In November 2015, 10 rural fire departments (27 firefighters) were provided wildland fire training. There were no Freightliner trucks received from the Department of Defense (DOD). Six DOD vehicles valued at \$471,174.00 were issued to VFDs. Two hundred forty seven DOD Recycling Control Point items valued at \$16,832.06 were received for redistribution to VFD's such as shovels and wrenching bars.

Rural Fire provided 1 interest free loan through the Rural Fire Revolving Loan Fund in November 2015 for \$15,130.85 to Fairview (White County) for a 2008 Freightliner – Turnkey Firefighting Conversion.

The RFP shop completed maintenance on five AFC vehicles and equipment.

**Firewise:** Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 145 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In November, Firewise staff assisted 55 communities with Firewise renewal efforts, conducted one initial presentation about the Firewise program and presented one risk assessment training. Staff conducted a wildland fire training and attended a webinar for ISO training and how it can interact with Firewise.

Firewise staff worked with two Girl Scout troops to earn the new Firewise patch, assisted with renewal paperwork, processed grant and renewal paperwork for Firewise Communities. Staff worked diligently to call and visit fire departments to assist in renewal efforts. Staff visited with 10 AFC county and district offices, met with three county Office of Emergency Management coordinators and met with 35 fire chiefs to provide them with information. Staff also provided educational material for 30 events and created five media releases.

**Law Enforcement:** AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, wildfires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In November, AFC Investigators and district law enforcement officers opened 5 timber, 1 dumping, and 2 fire cases.

The AFC law enforcement investigators patrolled the Arkansas State Forest during modern gun deer season.

An AFC law enforcement investigator gave a presentation on the search and rescue mission of the AFC downed pilot at an aviation meeting for the Georgia Forestry Commission in Brunswick, GA. This investigator also took the arduous walk test in Paris, AR.

### **FOREST MANAGEMENT**

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,801 landowners owning 882,087 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,305 Forest Stewards owning 282,085 acres.

For November, 6 FSP plans were prepared on 742 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 36 rural forestry management plans on 3,810 acres. AFC personnel conducted 3 prescribed burns on 50 acres.

**Urban Forestry Assistance:** Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

Over 2,000 students at eight schools participated in the Shade Trees on Playgrounds (STOP) program this year. During the months of October and November tree planting ceremonies were held at: Crossett, Mena, Des Arc, Newport, Hot Springs Village, Van Buren, Clinton and Cotter.

Trees have been proven to dramatically reduce the exposure of damaging sunrays and therefore increasing the amount of time one can spend outside without getting sunburned. Many playgrounds around the state are found in very sunny locations with little to no shade. Sun damage to the skin during childhood is the leading cause of skin cancer in adults. S.T.O.P. is the acronym for Shade Trees on Playgrounds. The STOP program was established twelve years ago.

Curriculum is provided for the schools by the Forestry Commission about the importance of trees not only to people but also to the environment. The children learn about how shade can help stop skin cancer as well as how trees help provide clean air and water, buffering for wind and noise, wildlife habitat, food, wood for homes and providing places to enjoy the outdoors. The teachers are instrumental in teaching the

kids about trees and helping them put together programs to present to parents, members of the community and AFC personnel who assist with the tree planting ceremonies.

AFC provides five hardwood shade trees such as oak, black gum, tulip poplar and maple for the children to plant at the end of the ceremony. Forty-seven shade trees were planted at the schools.

Forest Health: The Forest Health Specialist assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

The Forest Health Specialist and Assistant State Forester represented AFC at the Arkansas Monarch and Pollinator Strategy Meeting. This meeting brought together multiple agencies and stakeholders to develop a realistic strategy for the restoration of monarch and pollinator habitat statewide.

With the return of frequent rain and colder temperatures in November, forest pest activity subsided. Foresters and the forest health specialist responded to numerous cases of dying pine trees. The recent period of drought stressed trees and made them vulnerable to bark beetle attacks, which primarily involved pine engraver beetles (*Ips* spp.).

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15. Through the end of November there were 335 on line seedling orders. Seedling sales resulted in 941,000 pine compared with 770,100 last year during the same period. Last year at this time the total hardwoods sold were 1,815,850. This year we have sold 2,636,450 through the end of November. There was also an increase in hardwood seedlings sold on contract. Last year we contract grew 1,200,000 hardwood seedlings for one nursery from Leland MS. This year we have one nursery from Crowville LA that we are contract growing 1,200,000 hardwood seedlings and another nursery from Rayville LA contract 330,000 hardwood seedlings with AFC.

A major part of the nursey operation is estimating the number of seedlings that will be large enough to meet specs for seedling sales. A very complex system of counting plots for each species is conducted until the estimated inventory reaches a confidence interval of at least 95%. This inventory was completed in November. Harvesting of this year's seedling crop will officially begin in January. In preparation of the seedling harvest the Baucum crew serviced and steam cleaned all tractors and repaired all equipment that was in need of repair.

The nursery crew is also preparing for fall planting all the species possible for the FY17 crop. One part of this process is preparing the field after the methyl bromide application. Another component is receiving and preparing all of the seed. The preparation process includes floating seed to insure that all seed planted is viable and sizing the seed so that the machine will accurately space seed during planting. All of the Black Walnut and Sawtooth Oak were planted and some of the Cow Oak was planted before we were deluged with rain.

**Tree Improvement:** AFC's tree improvement program provides landowners with the highest possible genetic gain in pine and hardwood seed. One of AFC's objectives in tree improvement is establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery makes available to landowners the improved varieties of pine and hardwood, which is the result of the tree improvement program.

In preparation for out planting the next progeny test, the Bluff City crew moved the containerized loblolly pine from the greenhouse to the shade house for the seedlings to harden off. The test site was recently cleared with a dozer so there is a lot of bare ground. The area cleared is much larger than the upcoming planting will require, so winter wheat was planted in the cleared area that will not be a part of the test that will be planted this winter. The balance of the cleared site will be used for progeny tests in the future.

Top grafts in the new orchards require a lot of pruning below the graft to prevent the new graft from being overtaken. All of the top grafts were pruned during the month of November. The crew also began conducting the orchard inventory which matches up living trees with their proper location and positions where the tree may have died and needs to be replanted. Maintaining identification is a major part of orchard management, on inventory forms, maps and actual tagging of the tree. New identification tags were placed on all 748 trees in orchard #1714.

The 14 pieces of US Forest Service equipment from Louisiana that AFC took possession of in September were all delivered to Bluff City at that time. In November, the FoBro Kultri-Rotor Bed Shaper, Whitfield Hardwood seed sower, FoBro Hardwood Lifter, Silver Mountain Lateral Root Pruner, and a 1,000 gal tank mounted on trailer were transferred to Baucum Nursery.

The reforestation Manager along with the help of the AFC crew from District-5 completed data collection for two, 20 year old loblolly pine tests (2,550 positions) at Malvern. Height and diameter were recorded for all trees in each of the tests. The data collected at age 20 is designed to replicate a crop rotation. Prior to rotation age estimates of genetic growth at rotation age are used. The confirmation of those estimates is a vital part of the tree improvement process.

The reforestation Manager attended the Advisory Committee meeting for the Southern Forest Nursery Management Cooperative at Auburn University. This meeting is designed to review the research accomplishments of the previous year and to develop the plan for the next year as well as review all financial reports of the coop.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

The BMP Coordinator conducted one courtesy exam in Faulkner County with 3 participants consisting of two Foresters and the AFC's BMP Coordinator. Copies of Arkansas' BMP Implementation Reports, AFC's manual "BMPs for Water Quality Protection", the water quality complaint process and MOU with ADEQ were provided. An overview of the AFC's voluntary BMP program was also provided along with technical assistance and training to help with their SFI program and audits.

In November, one complaint was received which was found to be valid in Pulaski County. The complaint was investigated by the BMP Coordinator and is being mitigated. No referrals were made to the AFA or ADEQ. The complaint involved a water quality impairment problem with stream crossing.

The BMP Coordinator conducted one technical logger training session for foresters, loggers and contractors for Plum Creek held in conjunction with the Arkansas Timber Producers Association (ATPA). The training was held in Crossett, AR with 46 participants.

The AFC and State Forester Joe Fox were recognized by the U.S. Fish and Wildlife Service Southeast Region for their commitment and dedication to Fish and Wildlife conservation efforts as a partner of the Arkansas Unpaved Roads group.

The BMP Coordinator is working on the logistics of hosting the Southern Group of State Forester's (SGSF) Water Resource Manager's bi-annual meeting to be held in Little Rock, Arkansas March 1-3 2016.

The BMP Coordinator continues to work with the SGSF's Water Resources Committee to draft a letter for the SGSF to file for comment to the EPA's response for regulation of Forest Roads Discharges. He is also working on a draft letter for Arkansas as well.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

For November, the FIA personnel measured and submitted data on 58 plots. We are currently 93% complete with this year's work. FIA's goal is to have all remaining plots completed by the end of December.
