Quarterly Report Statistics and Information

This quarterly report, submitted January 1, 2016, contains a statistical profile of the Medicaid fraud referrals, audits, investigations, recoveries, and initiatives from the Office of the Medicaid Inspector General (OMIG) for the Fiscal Year 2016 (July 1, 2015 to December 31, 2015).

For the purposes of this report, the information is divided in the following manner: July 1, 2015 through September 30, 2015; and October 1, 2015 through December 31, 2015.

Recoveries/Recoupments/Initiatives

July 1, 2015 to September 30, 2015 recoveries by OMIG and recoupments sent to DHS Accounts Receivable for collection.

Referrals of Fraud and Prosecutions

A. Arkansas Attorney General's Medicaid Fraud Control Unit

Pursuant to Ark. Code Ann. §20-77-2506, the Medicaid Inspector General shall work with the Medicaid Fraud Control Unit (MFCU), of the Office of the Arkansas Attorney General, prosecuting attorneys and law enforcement agencies. The Medicaid Inspector General refers audit investigations to MFCU when there is a credible allegation of fraud. *See 42 CFR §455.23.*

From July 1, 2015 to September 30, 2015, **seven** Medicaid provider investigations have been referred to the Medicaid Fraud Control Unit of the Attorney General's Office. In addition, the Attorney General's Office referred one Medicaid provider for suspension to OMIG.

From October 1, 2015 to December 31, 2015, **twelve** Medicaid provider investigations have been referred to the Medicaid Fraud Control Unit of the Attorney General's Office.

B. Other Suspected Fraud Referrals

In addition to referrals of suspected fraud to the Arkansas Attorney General's Office, OMIG shall also make referrals and coordinate efforts with other federal, state and local law enforcement agencies. *See Ark. Code Ann. §20-77-2506(2).*

From July 1, 2015 to September 30, 2015, **one** Medicaid recipient investigation has been referred to local law enforcement.

From October 1, 2015 to December 31, 2015, **twelve** Medicaid recipient were referred to the appropriate agency for further investigation.
