Re: Arkansas Forestry Commission monthly activity report for December 2015

Dear Senator Sample and Representative Branscum:

Per Act 890 of the 90th General Assembly, Regular Session, 2015, Section 47, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for December, 2015.

Late December begins the season for AFC's Baucum Nursery to start lifting seedlings to supply Arkansas and our neighbors with high quality trees. Weather permitting, crews of 8 to 15 contract staff and 4 full time employees will lift an estimated 3.6 million hardwood and 2.2 million pine seedlings this year (a total of 5.8 million). We sell our seedlings to small forest landowners and large planting contractors all across Arkansas and a bit beyond our borders.

As you can see, we are very proud of our Nursery operation that provides quality seedlings to Arkansas and surrounding states forest landowners....and has been since 1935.

ARKANSAS FORESTRY COMMISSION December 2015 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During December a total of 23 wildfires were suppressed for a total of 244 acres. Ten year average for the month of December is 47 wildfires for 623 acres burned.

Storm Damage Assistance: An AFC crew from Nevada County assisted by clearing downed trees in the Willisville area.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In December 2015, 32 rural fire departments (93 firefighters) were provided wildland fire training. RFP received 0 Freightliners from Department of Defense (DOD), 2 Cargo Containers (\$2,648), 2 Utility Trailers (\$5,000). There were 11 DOD vehicles (Valued at \$936,395) and 2 Generators (Valued at \$2,022) issued to VFDs. 0 DOD Recycling Control Point (RCP) items were received for redistribution to VFD's.

Rural Fire provided 4 interest free loans via the Rural Fire Revolving Loan Fund in December 2015.

The RFP shop completed maintenance on five AFC vehicles and equipment.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 145 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In December, Firewise staff assisted 60 communities with Firewise renewal efforts, conducted two initial presentations about the Firewise program, and one Wildland fire training. Staff attended Dozer academy committee, the AFFF memorial committee and attended SAW class as teacher and student. Staff assisted with renewal paperwork and processed grant and renewal paperwork for Firewise Communities. Staff worked diligently to call and visit fire departments and assist in renewal efforts. Firewise staff visited with 15 AFC county and district offices to discuss Firewise programs in their area and met with 20 fire chiefs to provide information on Firewise.

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In December, AFC Investigators and district law enforcement officers opened 4 timber, 2 equipment theft/vandalism and 2 fire cases.

In December, an AFC law enforcement investigator gave a law enforcement presentation to the Vender Prescribed Fire School in Conway. He participated in a "Shop with a Cop Program" in Waldron, AR.

AFC law enforcement investigators patrolled the State Forest ending the modern gun deer season.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,758 landowners owning 869,558 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,299 Forest Stewards owning 280,476 acres.

For December, 3 FSP plans were prepared on 499 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 29 rural forestry management plans on 1,658 acres. AFC personnel conducted 13 prescribed burn on 776 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

- AFC partnered with the Arkansas Urban Forestry Council, the University of Arkansas Medical Sciences (UAMS), and the Division of Agriculture Research & Extension to hold *Tree Campus USA: Healthy Trees, Buildings and People*, a workshop for UAMS employees. The 27 attendees learned about: Tree Campus USA, the physical and social benefits of trees, and native species selection.
- AFC Staff participated in the Arkansas Forestry Association's *Forest Awareness Day* in the Ozark National Forest. Each year, 5th grade students from area schools attend an educational field day at Lake Wedington where groups of students rotate through activity stations participating in educational activities focused on our forests, wildlife, habitats, aquatics, watersheds, and nature.
- John Brown University applied for Tree Campus USA designation in 2015. Therefore JBU facilities management wants to insure that the individuals who care for campus trees are properly trained. University staff contacted AFC personnel who, with the University of Arkansas Research and Extension, conducted a tree management workshop for the grounds crew. The training program included presentations on proper pruning, soils, pests, proper planting and care, tree restoration after construction as well as hands-on training outdoors.

Forest Health: The Forest Health Specialist assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

- The Forest Health Specialist attended the Cooperative Agricultural Pest Survey. This group, led by the Arkansas State Plant Board and USDA Animal and Plant Health Inspection Service, determines the surveys that will be implemented throughout the state in order to detect or monitor for the presence of invasive insects. AFC will assist with emerald ash borer, walnut twig beetle, and gypsy moth surveys in 2016.
- Loblolly pine trees in a large area of Hot Spring County were observed with browning needles. The cause is suspected to be pine needle blight, a native fungus that affects the foliage. Heavy rains and moderate fall temperatures may have contributed to this outbreak. Using an aerial survey, AFC mapped over 1,300 affected acres. Needle blight rarely kills trees, but the size of this outbreak should not be overlooked. Landowners should monitor the recovery of these trees, and seek professional help to determine if a harvest is necessary.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15. Through the end of December there were 433 on line seedling orders. Seedling sales resulted in 1,126,600 pine compared with 1,048,875 last year during the same period. Last year at this time the total hardwoods sold were 1,932,350. This year we have sold 2,908,450 through the end of December. There was also an increase in hardwood seedlings sold on contract. Last year we contract grew 1,200,000 hardwood seedlings. This year we have contracts to grow 1,500,000 hardwood seedlings.

In preparation of the seedling harvest the Baucum crew serviced and steam cleaned all tractors and repaired equipment as needed. The nursery crew is also preparing for and fall planting all the species possible for the FY17 crop. One part of this process is preparing the field after the methyl bromide application. Another component is receiving and preparing all of the seed. The preparation process includes floating seed to insure that all seed planted is viable and sizing the seed so that the machine will accurately space seed during planting. All of the Black Walnut and Sawtooth Oak were planted and some of the Cow Oak was planted before we were deluged with rain.

Below are the species and pounds of seed received in December which will used for the FY17 crop.

Other accomplishments before the rains came were. Lateral pruned 1/3 of the pine crop. This process cuts the roots back on 2 sides of the plant and encourages new root growth after planting. Removed footings from old greenhouse in preparation for the new pine packing house. Harvested and shipped 503,000 hardwood seedlings for one of the nurseries for which we are contract growing for.

Tree Improvement: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

The orchard establishment process begins with grafting the desired clone of a seedling onto potted rootstock. The grafts are done in the greenhouse to allow the optimum environment for the success of the graft. After enough time has passed for the successful graft to occur, the successful grafts are moved out to the shade house to acclimate to the wind and some filtered sun. The Bluff City crew has been field planting the potted grafts in the newest orchards during the months of November and December.

The Reforestation Manager along with the help of the AFC crew from District-3 completed data collection for two hardwood progeny tests at Lonoke; one twenty year old nuttall oak test with 1,120 total positions and one 16 year old sweetgum test with 2,112 total positions. Height and diameter were recorded for all trees in each of the tests.

These measurements completed the necessary data collection for this season, which is long before the February 1, 2016 deadline.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

- Conducted one courtesy exam in Yell County with one Forester and two loggers. The exam addressed Skidder stream crossings.
- Closed-out one valid complaint in Pulaski County involving water quality impairment from a stream crossing. The site visit and report of successful mitigation were submitted to the ADEQ field inspector, and logger.
- Conducted one technical logger training session for Foresters, Loggers and Contractors for Evergreen Corporation held in conjunction with the Arkansas Timber Producers Association (ATPA). The training was held in Pine Bluff, AR. and was attended by 34 participants.
- Working on the logistics for hosting the Southern Group of State Foresters (SGSF) water resource manager's bi-annual meeting to be held in Little Rock, Arkansas March 1-3 2016.
- Continues to work with the SGSF Water Resources Committee to draft a letter for comment on the EPA's response for regulation of Forest Roads Discharges. Simultaneously working on a draft letter for Arkansas as well.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

The FIA crew has completed 61 plots for the month of December.
