Subject: Alternative Fuel Vehicle Report

This report is provided in accordance with Ark. Code Ann. §19-11-217(2)(A) which requires the Office of State Procurement to report on the state's usage of alternatively fueled vehicles. The report addresses acquired vehicles that help to reduce the overall annual petroleum consumption by state agencies.

This report includes:

- (a) The number and type of alternative fueled vehicles used by each state agency;
(Attachment A)
- (b) The difference between the acquisition cost, maintenance, and operation of alternative fueled vehicles and comparable conventionally fueled motor vehicles; **(Attachment B)**
- (c) An evaluation of the plan's success; and
- (d) Suggestions for modifying the plan.

The initial step taken by the Office of State Procurement was creating a state-wide contract for alternative and hybrid vehicles, beginning with the 2006 models. Each year since the inception of this contract, it has been modified to increase and encompass the market of available vehicles.

The purchase of alternative fueled vehicles is based on available funding, the State's emphasis on the use of hybrid or alternative fueled vehicles, the availability of competitively priced vehicles and alternative fuels, and the active participation of the state agencies. There continues to be a significant purchase price difference between alternative fueled vehicles and conventionally fueled vehicles. **Attachment B** is a comparison of acquisition cost, average gas mileage, annual gas costs and savings, based upon an average of \$2.21 per gallon of regular unleaded gasoline. The format of this report has changed from previous reports, attempting to depict a closer equivalent comparison to the alternative fuel vehicle type, based on the awarded 2015 state contract.

Ark. Code Ann. §15-13-205 required the Department of Finance & Administration to implement a policy regarding the standard of biofuel usage, effective January 1, 2009. The policy states that when available and economically feasible, all State agencies are required to purchase diesel fuel that contains at least a minimum of two percent (2%) biofuels by volume for all State diesel powered motor vehicles, light trucks and equipment. The average diesel cost in 2015 was \$2.71 per gallon. This policy works in

tangent with the desire to purchase alternative fueled vehicles to help reduce petroleum consumption by state agencies.

This report covers the twelve month period from October 1, 2014 through September 30, 2015, which corresponds closely with the annual new vehicle contract developed by the Office of State Procurement. State agencies order most of their new fleet vehicles between October and March. As of September 30, 2015, the state had 1,652 vehicles that fall into the alternative fueled category. This figure includes those alternative or hybrid fueled vehicles purchased from contracts developed and also awarded by the Arkansas Highways and Transportation Department. The current percentage of alternative fuel vehicles is 19.10% of the 8,649 vehicles in the state fleet as of September 30, 2015. The purchase of alternative fueled vehicles has kept abreast of what the market currently bears relating to the life cycle cost of both types of vehicles.

The 2015 vehicle contract issued by the Office of State Procurement included the following:

Hybrids:

- Chevrolet Volt
- Nissan Leaf
- Toyota Camry
- Toyota Prius

Bi-Fuel/CNG:

- Chevrolet Express ¾ Ton Cargo Van
- Chevrolet Express 1 Ton Cargo Van
- Chevrolet 2500 HD Crew Cab
- Dodge Ram 2500 Crew Cab
- Chevrolet Impala

The state contract has been expanded over the last couple of years to include dedicated CNG vehicles. In addition, there are several Bi-Fuel vehicles that can use CNG or regular gasoline. These efforts, along with the opening of the several CNG fueling stations, helps to position the state to migrate to this type of vehicle as the purchase price becomes more competitive. The Office of State Procurement maintains a life cycle cost comparison chart on state contract vehicles to assist entities in making an informed decision when purchasing a vehicle.

The purchase price of an alternative fueled vehicle and the availability of fueling stations have restricted the number of alternative fueled vehicles in the state's fleet. The Office of State Procurement plans to continue to increase the breadth of offerings on the vehicle contract to provide agencies a wider variety of alternative fueled vehicle options. The Office of State Procurement, working with the Arkansas Energy Office, continues to disseminate information to educate agency personnel about alternative fuels, vehicles and their availability in Arkansas. Education of agency personnel is the key to the success of the long-term plan of reducing usage of petroleum-based fuel products for State vehicles and equipment.
