# Breast Cancer Control Fund Annual Progress Report 

January 1, 2016
This report includes fiscal year 2015 amounts budgeted, allocated and expended for the BreastCare program for testing, diagnosis and outreach. ADH staff works collaboratively with the Department of Human Services (DHS) and healthcare providers to navigate women with a breast or cervical cancer diagnosis to health insurance coverage or for treatment assistance. ADH staff works closely with patients to determine appropriate resources for each individual while in treatment.

BreastCare, administered through the Arkansas Department of Health (ADH) and under the oversight of an advisory board, is a comprehensive early detection program providing breast and cervical cancer screenings and diagnostics to eligible women. In state fiscal year 2015, BreastCare served more than 5,000 women. Its services included 2,503 mammograms and 1,913 Pap tests. This resulted in 66 women being diagnosed with breast or cervical cancer. Over seventy-five percent of women who received a diagnosis of breast cancer while in the BreastCare program had an early stage cancer diagnosis, stage $0-\mathrm{II}$. The high costs and poor outcomes associated with late stage diagnosis and treatment make the case for regular breast cancer screening stronger than ever (Source: BreastCare On-Line System).

# Breast Cancer Control Fund Addendum 

Gap Treatment Funding
January 1, 2016
This is an addendum report for the fiscal year 2014, one-time funding for treatment of women diagnosed with breast or cervical cancer while ineligible for health insurance coverage.

Since the funding was made available in April of fiscal year 2014, BreastCare has assessed over 200 women for assistance. Ninety-eight women have participated in the treatment progam, 32 of those are currently participating, and 128 women were navigated to other coverage. As of December 11, 2015, $\$ 939,686$ has been spent.
