Per Act 59 of the 89th General Assembly, Fiscal Session, 2014, Section 48, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for January, 2017.

January allowed AFC to conduct a Forest Management Academy for new employees and those that have promoted to positions where training is essential. Classes offered were; Basic Forest Management (last taught 2008), Management Plan Development and Best Management Practices. There were 100 certificates given to employees that attended the classes.

These classes instruct the employees on proper management techniques as well as requirements for private landowners that seek federal assistance when it comes to being certified as Stewards of Arkansas's forests.

We at the AFC strive to train new and seasoned employees in order to bring quality tools such as Forest Management Plans to the Stewards of our forests.

ARKANSAS FORESTRY COMMISSION January 2017 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During January a total of 167 wildfires were suppressed for a total of 3694 acres burned. The ten year average for the month of January is 141 wildfires for 2061 acres burned.

Search and Rescue Assistance: An AFC crew from Pike County helped with a search and rescue effort for a 58 year old female with dementia east of Kirby. She was found and treated. An AFC crew of rangers from Benton, Carroll, and Madison Counties assisted in a search and rescue effort for a 73 year old female in Huntsville.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments (VFDs) with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In January 2017, 41 rural fire departments (121 firefighters) were provided wildland fire training, including one minority department.

RFP received nine Freightliners (Valued at \$1,400,616.00) and three Pumper Trucks (Valued at \$507,325.02) from Department of Defense (DOD). Additional items obtained from the Department of Defense include: two water units (Valued at \$65,000.00), two-10 ton floor jacks (Valued at \$4,376.00), two-350 GPM Pump on wheels (Valued at \$54,420.00), one-10KW Generator on trailer (Valued at \$25,757.00) and one Dodge yard tug (Valued at \$4000.00).

There were six Department of Defense (DOD) vehicles issued to VFDs including four Freightliners (Valued at \$569,501.00) and one Pumper Truck (Valued at \$169,130.50).

There were two FEPP (Federal Excess Personal Property) boats issued to VFDs including with trailers and motors (Valued at \$36,680.79).

21 DOD Recycling Control Point (RCP) items were received for redistribution to VFD's (Valued at \$8,379.00) including battery chargers.

Rural Fire provided one interest free loan via the Rural Fire Revolving Loan Fund in January 2017.

The RFP shop completed maintenance on ten AFC vehicles, one Dozer, and four DOD Vehicles

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 166 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In January Firewise achieved the following:

- Conducted 13 Initial Presentations and four risk assessment trainings
- Visited with 20 Fire Chiefs regarding Firewise activities.
- Attended Hot Springs Village Business Meeting to provide Firewise Education and to present a 10-year award.
- Attended three trainings.

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In January, AFC Investigators and district law enforcement officers opened four dumping, 14 arson, and 19 timber cases.

An AFC Law Enforcement Investigator attended Forestry Day at the State Capitol.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,922 landowners owning 905,056 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,313 Forest Stewards owning 284,683 acres.

For January, 15 FSP plans were prepared on 3,198 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 128 rural forestry management plans on 9,171 acres. AFC personnel conducted 26 prescribed burns on 1,523 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

This was the thirteenth year for the Shade Trees on Playgrounds program (STOP). This year more than 3,000 students at seven schools participated in the (STOP) program. Tree planting ceremonies were held at: Monticello, Dierks, Ward, Jonesboro, Pottsville, Morrilton and Pocahontas.

Curriculum is provided for the schools by the Forestry Commission about the importance of trees, not only to people but also to the environment. The children learn about how shade can help stop skin cancer as well as how trees help provide clean air and water, buffering for wind and noise, wildlife habitat, food, wood for homes and providing places to enjoy the outdoors.

AFC provides five hardwood shade trees, which included a variety of oaks, maples and tulip poplars for the children to plant at the end of the ceremony. Thirty-five shade trees were planted at the schools.

Forest Health: The Forest Health Specialist, Chandler Barton, assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

- A drought is occurring in northwestern Arkansas. Such an event can cause subsequent *Ips* pine engraver beetle outbreaks. This native beetle typically kills sporadic trees in any given year, but an outbreak population spurred by drought can kill a noticeable percentage of a pine forest. Also, landowners should know that hardwood tree death may occur several years after a drought. AFC will be monitoring for *Ips* outbreaks and alert the public so that urgent mitigation and harvesting can take place before the resource is severely affected.
- The Forest Health Specialist gave several presentations, increasing his outreach presence in the state. A presentation on invasive species was given to Har-Ber High School in Springdale. Natural resource education is increasingly important for our future land managers.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15. Through January 30, there were 445 online orders and 92 traditional orders for total sales of 2,308,945 pine and 4,764,675 hardwood seedlings. Comparatively, in the same period in 2016, there were 418 online orders and 77 traditional orders for total sales of 1,911,700 pine and 2,913,225 hardwood seedlings.

Staff completed lateral pruning of all bare root pine seedlings. Lateral pruning is done to help promote new root growth after planting and to make it easier for tree planters to properly plant bare root pine.

Nursery technicians received the following pounds of seed in January, which will be planted as part of the crop for FY'18.

Tree Improvement: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

In January the Tree Improvement staff packed and delivered 33,000 containerized "lost" pine seedlings (a loblolly pine that is isolated to the Pine City area that is genetically unique from others) which were grown for the Arkansas Heritage Commission. They also packed and delivered 9,900 containerized 3-star loblolly pine for distribution to AFC customers. The staff also made ID tags for 997 trees in AFC's orchards.

Staff marked and flagged 2440 positions on, 12ft x 12ft spacing for seedlings to be planted in a growth and yield hardwood test on Dr. Rob Parkes property in Scottsville, AR. This eight acre test will provide empirical data on the differences between Improved Nuttall oak vs unimproved Nuttall and Improved Cherrybark oak vs unimproved Cherrybark oak. This test will also compare and contrast the two species.

The Reforestation Manager attended the Western Gulf Forest Tree Improvement Program Steering Committee meeting in Shreveport LA on January 17. The purpose of this meeting was to discuss major issues within the cooperative and present recommendations to the Executive Committee for a vote.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

The BMP coordinator responded to one timber harvesting complaint in Pulaski County. The complaint involved water quality impairment problems with Streamside Management Zone and the tracking of excessive soil onto state highway. The complaint was addressed and mitigated by BMP Coordinator and ADEQ field inspector.

The BMP coordinator provided three technical logger training sessions this month. The BMP Coordinator also provided a BMP training for Potlatch Foresters, Loggers and Contractors. The training was well attended, with approximately 80 participants.

The BMP coordinator continues to work with the Arkansas Forests and Drinking Water Committee. The Committee is planning to formalize a working group, mini strategic plan, and mission statement in the first quarter of 2017.

The BMP coordinator represented AFC at the Arkansas Forestry Association (AFA) Education Committee meeting. The meeting was to schedule upcoming and potential landowner workshops for 2017.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

During January, the FIA crew completed 60 plots and are now 75% complete with the 2016 survey.
