During the third quarter of fiscal year 2017, the Arkansas Securities Department collected a total of \$44,000.00 in fines assessed from Orders. \$26,000 was deposited to Special Revenue, Fund SIE0000, and \$13,000 was deposited to General Revenue. A listing of the orders by the case name with detail of the amounts collected is provided on the attached spreadsheet. There were no settlements or agreements that directed payments to third parties. Copies of the Orders are available on the Department's website at <u>www.securities.arkansas.gov</u> under the legal section.

Pursuant to the Arkansas Securities Act, fines paid for violations involving the Securities Act are deposited into the Investor Education Fund, until the balance reaches \$150,000. Securities Act fine money in excess of \$150,000 collected in any one year is designated as general revenues. Fines collected pursuant to the Fair Mortgage Lending Act are designated as general revenues.

During the second quarter there were \$463.09 in expenditures from the Investor Education Fund. Expenditures include \$65.69 for fuel for the state car and \$397.40 for travel related expenses. The Investor Education program made 11 presentations to approximately 397 persons. The programs included presentations on Planning for Retirement that were directed to state employees, Stock Market Game – Investing for teachers, and Investing Basics for finance classrooms of higher education.
