HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$5,903.7 million have increased \$58.4 million, or 1.0%, above the \$5,845.3 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$339.2 million increased \$1 million, or 0.3%, from the \$338.2 million available for distribution in May 2016. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,543,399.02 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$27,977,389.22.

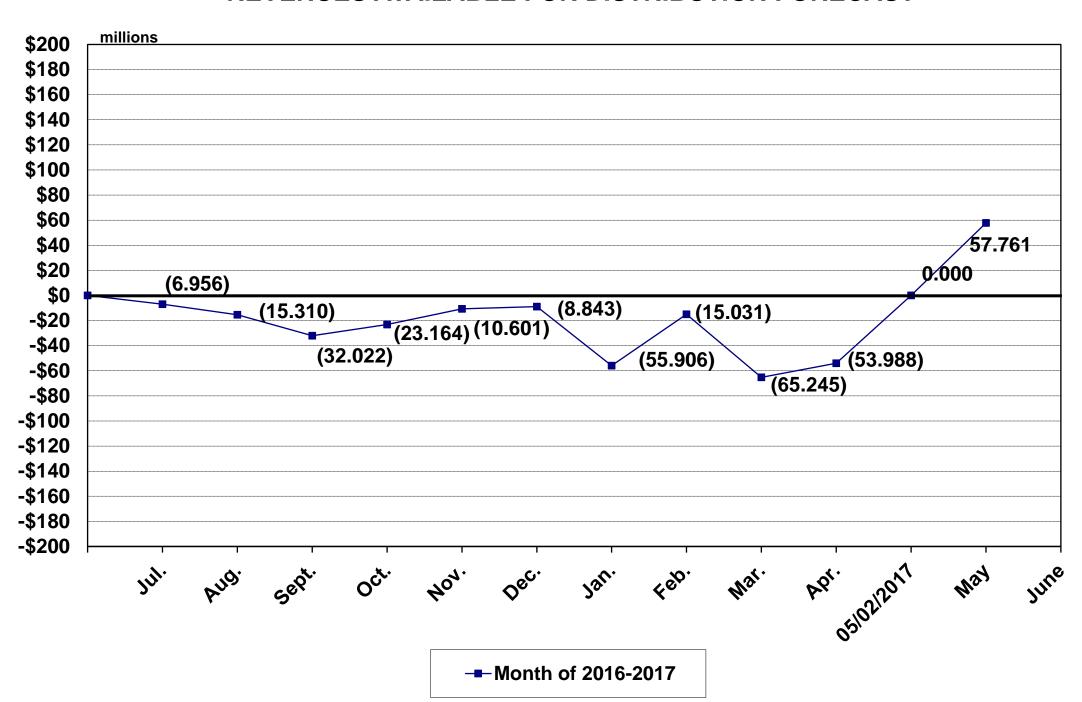
