Dear Senator Sample and Representative Branscum:

Per Act 59 of the 89th General Assembly, Fiscal Session, 2014, Section 48, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for May 2017.

The AFC was proud to be part of the 2017 Wildland Fire Academy this month. This Academy is a partnership training that emphasizes wildland fire suppression techniques that enhances the abilities and skills of each firefighter. Partners include AFC, U.S. Forest Service, U.S. Fish and Wildlife, Arkansas Game and Fish Commission, Bureau of Indian Affairs, Arkansas State Parks, National Parks Service, The Nature Conservancy, Chloeta of Oklahoma and others.

In all, 228 students from nine different states participated from 13 federal, state and private agencies. 46 AFC students were among these that accomplished needed training to ensure public safety when suppressing wildfires in Arkansas. Also, eight AFC Foresters and Rangers served as instructors and field observers.

The AFC strives for excellence by continuing education and training for its employees.

ARKANSAS FORESTRY COMMISSION May 2017 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During May a total of 10 wildfires were suppressed for a total of 35 acres burned. Ten year average for the month of May is 32 wildfires for 318 acres burned.

Search and Rescue Assistance: An AFC crew from Searcy County assisted in a search and rescue for a lost hiker on the Ozark Highlands Trail in the Ozark National Forest.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments (VFDs) with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop also provides maintenance to AFC equipment.

In May 2017, 47 rural fire departments (115 firefighters) were provided wildland fire training, including three AFC personnel.

RFP received five Freightliners (valued at \$667,662.00), two Brush trucks (valued at \$120,377.00), one Pumper Truck (valued at \$18,000.00), two Service Blazers (valued at \$65,980.00) and one Maintenance truck (valued at \$14,141.00) from the Department of Defense (DOD).

RFP received from FEPP (Federal Excess Personal Property) one Mobile home (valued at \$50,000.00) and two Boston Whaler Boats, motor and trailers included, (valued at \$70,639.00).

There were four DOD vehicles and equipment issued to VFDs including one Freightliner (valued at \$166,223.00), one Brush Truck (valued at \$31,248.00) and two generators (valued at \$52,462.00).

There was one FEPP mobile home (valued at \$50,000.00) issued to AFC FireWise.

1,590 DOD Recycling Control Point (RCP) items were received for redistribution to VFD's (valued at \$95,002.87) including light sets, spill kits, hook and line kits, fire equipment nozzles, first aid kits, marker lights, hand entrenching tools, industrial goggles, cargo tie downs, roll pack dressing, chemical lights, flashlights, gauze, tarpaulin, amplified speakers and identification markers.

Rural Fire provided two-interest free loans via the Rural Fire Revolving Loan Fund in May 2017.

The RFP shop completed maintenance on 10 AFC vehicles, and four DOD Vehicles

12 Wildland Wildfire Suppression kits were delivered or picked up as of May 31, 2017, for a total of 59 to date.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 167 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In the month of May Firewise achieved the following:

- conducted three Firewise initial meetings
- conducted Risk Assessment training, assisted community with CWPP
- attended the Rural Services Conference in Hot Springs with a Firewise booth
- attended the Fire Academy in Russellville

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. In May, AFC Investigators and district law enforcement officers opened four dumping, three fire, and eight timber cases.

An AFC Law Enforcement Investigator taught the FI-110 Wildfire Scene Protection class at the Wildland Fire Academy. He was guest speaker at the Washington County Waste Management meeting. This investigator assisted with the Scott County Fishing Derby, and instructed Defensive Tactics class at the Scott County Sheriff's Office.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and\or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,933 landowners owning 906,706 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,317 Forest Stewards owning 286,596 acres.

For May, nine FSP plans were prepared on 1,228 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 76 rural forestry management plans on 8,792 acres. AFC personnel conducted four prescribed burns on 91 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

AFC urban forestry staff have been busy keeping up with training, providing educational programs, conducting tree inventories, maintaining Tree City USA communities, and assisting with Arbor Day celebrations. In order to assist communities with their urban trees, it is important to offer educational tools and opportunities. Urban forestry was able to conduct a tree inventory at Altus City Park, thereby educating the community on what they have in order to better manage their urban forests. Staff attended training to become task leader specialist for the Urban Forestry Strike team. With this training, AFC will continue to have the only task specialist leader trained in the state. This will allow the AFC to have better response to any natural disaster that may affect urban trees in our state or region. An Arbor Day celebration was conducted at Dardanelle with over 150 3rd graders in attendance learning the importance of trees.

Forest Health: The Forest Health Specialist, Chandler Barton, assists AFC personnel statewide in efforts to maintain healthy, productive forest ecosystems by preventing, detecting, monitoring, and suppressing damaging insects and diseases. AFC offers technical assistance to landowners who encounter forest health issues.

- Chandler gave forest health presentations at the following events:
 - Board of Registered Foresters Spring Forester's Workshop
 - University of Arkansas Monticello School of Forestry Two-Week Short-Course
 - Western Gulf Forest Health Conference
- AFC placed emerald ash borer (EAB) traps in six counties that were previously unconfirmed. Three of these counties (Garland, Pike, and Montgomery) are now confirmed as a result of these traps. Following an initial county detection, EAB abundance increases steadily and as a result tree mortality is more noticeable in the several years after a detection.
- AFC observed browning oak trees speckled across the landscape of the western Boston Mountains. Affected trees were mostly white oaks (Quercus alba) displaying symptoms of various diseases, including oak anthracnose (Discula quercina), oak-pine rust (Cronartium quercuum), and jumping oak gall (Neuroterus saltatorius). Fortunately, most trees had some green foliage, and none of the diseases are expected to kill the white oaks on their own.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Seedling sales began on July 15. Final sales for the 2017 planting season (through the end of May) are as follows: there were 542 on line orders and 127 traditional orders for total sales of 2,351,425 pine and 5,007,159 hardwood. Comparatively, total sales for the 2016 planting season were as follows. There were 780 on line orders and 211 traditional orders for total sales of 2,168,950 pine and 2,207,350 hardwood.

A customer satisfaction survey was developed and mailed to each customer who purchased seedlings from AFC during the 2017 planting season. A total of 640 surveys were mailed. Results of the survey will be reported in June.

Tree Improvement: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

During the month of May, the Bluff City Tree Improvement staff completed the following: mixed soil for and filled 341 trays (128 cells per tray) and transferred to cold frame growing structure, planted 43,648 containerized 3 star loblolly pine which will be a part of the FY18 crop for Baucum Nursery, mixed soil for and filled 1,025 three gal pots, planted 100 water oak and 100 willow oak in three gal pots for rootstock, planted 825 loblolly pine in three gal pots for rootstock, worked on irrigation lines in and around greenhouses, finished grafting pine (over 300 grafts done in May with a total of 814 for the FY17 grafting season) confirmed progeny test maps for polymix test at Rosston and block plots at the old shortleaf seed orchard, aerial spray application of all production orchards and mixed soil for and filled 150 pots for trees to be donated for special tree planting ceremonies across the state.

The Reforestation Manager and Reforestation Foreman attended the Western Gulf Forest Tree Improvement Program (WGFTIP) annual contact meeting at DeGray Lake, AR. The meeting provided Western Gulf Forest Tree Improvement Program members a short course on the latest developments in tree improvement and WGFTIP programs.

Best Management Practices: Forestry Commission provides BMP training to loggers and timber companies, conducts courtesy exams prior to or during timber harvest operations and addresses logging complaints.

The BMP coordinator responded to one timber harvesting complaint in Nevada County this month. The complaint was a non-valid complaint. The BMP coordinator provided a courtesy exam to both landowners.

The BMP Coordinator conducted one courtesy exam one in Van Buren County with 4 participants. Participants consisted of four loggers, one landowner, AFC County Forester, County Ranger, and the AFC's BMP coordinator. The exam addressed the Arkansas Forestry Commissions BMP Program. The BMP Coordinator provided copies of Arkansas's BMP Implementation Reports, AFC's manual "BMPs for Water Quality Protection", the water quality complaint process and MOU with ADEQ.

The BMP Coordinator conducted one technical logger training session for Foresters, Loggers and Contractors. The training was held in conjunction with the Arkansas Timber Producers Association (ATAP) for West Frazier timber Company. The training was held in Booneville, AR. and was attended by 45 participants.

The BMP coordinator represented AFC and provided reports at the quarterly AFA Forest Practices Committee meeting

The BMP coordinator continues to work with the Arkansas Forests and Drinking Water Committee. The Committee finalized a vision statement, mission statement, mini strategic plan, for the 2017-18 year.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas's natural resource trends through time.

FIA completed 79 plots for the month of May. The 2016 Inventory has been completed and the 2017 Inventory has begun.
