Collections of Gross General Revenues year-to-date of approximately \$6,570.4 million have increased \$100.4 million, or 1.55%, above the \$6,470.0 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$571.7 million increased \$30 million, or 5.54%, from the \$541.7 million available for distribution in June 2016. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,543,399.02 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$30,520,788.24.

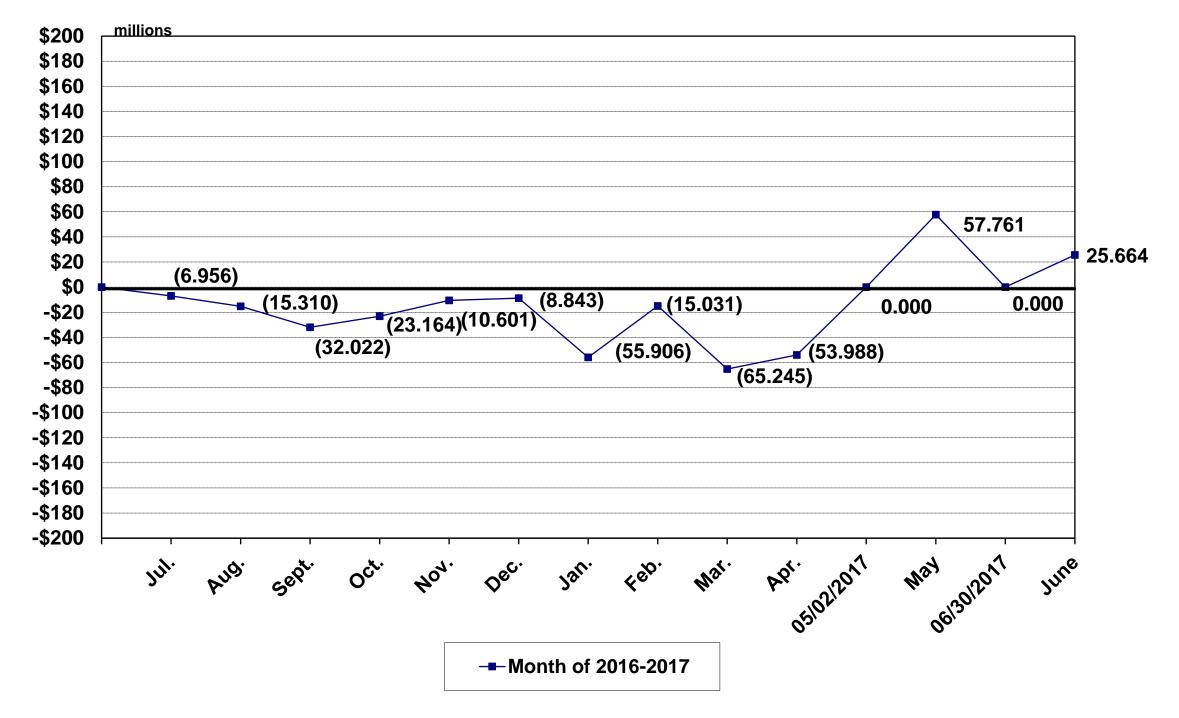
