Re: Arkansas Forestry Commission monthly activity report for June 2017

Dear Senator Sample and Representative Branscum:

Per Act 59 of the 89th General Assembly, Fiscal Session, 2014, the Arkansas Forestry Commission (AFC) is to report monthly fiscal and agency activities to the Arkansas Legislative Council. Please find attached the report for June, 2017.

In June, AFC received delivery of 4 dozers and transport trucks that will be used to upgrade existing wildland firefighting equipment replacing open tractor cabs with enclosed, environmental cabs.

Also in June, AFC hosted the annual Southern Group of State Foresters (SGSF) conference in Rogers. The SGSF provides leadership in sustaining the economic, environmental, and social benefits of the South's forests. SGSF members are from 13 southern states, Puerto Rico, and the U. S. Virgin Islands. SGSF member states work together to identify and address existing and emerging issues and challenges that are important to southern forests and citizens. Partners that contributed to hosting the conference include the Arkansas Forestry Association, American Forest Foundation, U. S. Forest Service and National Wild Turkey Federation.

AFC is proud to have hosted regional and national forestry leaders and showcased Arkansas's cultural and scenic attributes.

ARKANSAS FORESTRY COMMISSION June 2017 Activity and Fiscal Report

FIRE PROTECTION

Wildfires: During June a total of 14 wildfires were suppressed for a total of 64 acres burned. Ten year average for the month of June is 73 wildfires for 796 acres burned.

Search and Rescue Assistance: An AFC crew consisting of eighteen personnel assisted in a search and rescue for two women who were missing in Drew County. An AFC plane was used to help search. Both women were found alive and unharmed.

Rural Fire Protection: Rural Fire Protection (RFP) assists rural volunteer fire departments (VFDs) with organization, training and equipment. RFP provides interest-free loans and administers federal grants to assist approximately 1,000 volunteer rural fire departments. The RFP shop provides maintenance to AFC equipment.

In June 2017, 32 rural fire departments (114 firefighters) were provided wildland fire training with 3 AFC personnel in attendance.

RFP received 1-Freightliner (Valued at \$98,101.00), 3-Fire-Fighting trucks (Valued at \$154,432.00) and 2-John Deere mowers (Valued at \$600.00) from Department of Defense (DOD) Excess Property.

There were 6 (DOD) vehicles and equipment items issued to VFDs including: 3-Freightliners (Valued at \$403,278.00), 2- Brush Trucks (Valued at \$200,084.00), 1-Large Tanker (Valued at \$118,143.08) and 1 ATV (Valued at \$3,658.00).

There were 2-FEPP (Federal Excess Personal Property) equipment issued to fire departments including: 2-boats (with a trailer and 2 motors per boat) (Valued at \$ 70,639.00).

1,053 DOD Recycling Control Point (RCP) items were received for redistribution to VFD's (Valued at \$105,499.49) including: boots, nozzles, spotlights.

Rural Fire provided 1-interest free loan via the Rural Fire Revolving Loan Fund in June 2017.

The RFP shop completed maintenance on 9 AFC vehicles, and 2 DOD Vehicles.

All 62 Wildland Wildfire Suppression kits have been distributed to Volunteer Fire Departments.

The narrative and worksheets have been developed for submission to the U.S. Forest Service in preparation for the 2017 Wildfire Volunteer Fire (WFVF) Grant.

Firewise: Firewise staff and district personnel work with fire departments and civic organizations to make communities safer from the threat of wildfire through mitigation projects and community education initiatives. Arkansas leads the nation with 167 active Firewise communities. Recognized communities display Firewise signs at the city limits.

In June, Firewise staff:

- 1. Conducted three Risk Assessment trainings
- 2. Worked a Firewise booth at the Fire Chiefs Conference in Hot Springs
- 3. Attended the Southern Group of State Foresters Conference
- 4. Spoke at Yell County Chiefs meeting
- 5. Worked on New Firewise Office in Greenbrier (underpinning, windows, floor, bathroom, parking lot, electric, water, power washed, roof etc....)

Law Enforcement: AFC has the authority to enforce the laws of the State of Arkansas, but focuses primarily on unlawful dumping, timber theft, forest fires, and forestry equipment theft and vandalism. AFC aggressively seeks prosecution of violators to deter such crimes. AFC Investigators and district law enforcement officers opened 3 dumping, 0 fire, and 12 timber cases.

The AFC Law Enforcement Supervisor was the Incident Commander for the Southern Group of State Foresters meeting in Rogers, AR. Two AFC investigators provided security at the Southern Group of State Foresters meeting.

FOREST MANAGEMENT

Forest Stewardship/Rural Forestry Assistance Programs: AFC works with a diverse group of partners and professionals to conserve, protect, and enhance Arkansas's forests. The Forest Stewardship Program (FSP) is an opportunity for non-industrial private forest landowners who are interested in managing their property for wildlife, recreation, soil and water conservation, agro-forestry and/or for timber production to get a comprehensive multiple use forest management plan that is prepared by private consulting or AFC foresters, private consulting or AGFC private lands wildlife biologists, and USDA Natural Resource Conservation Service soil and water professionals. Arkansas has 4,943 landowners owning 907,525 acres that are enrolled in FSP. Landowners that implement practices under their FSP management plans become Forest Stewards. Arkansas has 1,317 Forest Stewards owning 286,566 acres.

For June, 18 FSP plans were prepared on 2,382 acres. In addition, AFC personnel provide technical assistance through the rural forestry program to landowners that are enrolled in USDA tree planting and forest management programs such as the Conservation Reserve Program, Environmental Quality Incentives Program, Wetland Reserve Program, and AFC Southern Pine Beetle Prevention and Restoration Program. AFC foresters prepared 173 rural forestry management plans on 9,316 acres. AFC personnel conducted 2 prescribed burns on 22 acres.

Urban Forestry Assistance: Urban Forestry Program staff provides assistance and training to communities, educational institutions, non-profit organizations, developers and homeowners on urban tree care, inventory and management.

AFC urban forestry staff have been busy keeping up training, providing educational programs, assisting with Southern Group of State Foresters meeting, maintaining Tree City USA communities, and assisting

with Arkansas Urban Forestry Council (AUFC) events. The AFC assisted with the AUFC ReLeaf event in Nashville, distributing potted trees to citizens. ReLeaf events take place in communities that have lost trees due to a natural disaster. In order to assist communities with their urban trees, it is important to offer educational tools and opportunities. Presentations on urban forestry and tree care were presented to more than 60 participants of the Mt. Holly Garden Club in Little Rock, Fairfield Bay community improvement group, and Arkansas Forestry Association's Urban Forestry workshop for teachers. Staff attended the AUFC Up by Roots workshop in Fayetteville and assisted the Wolf House in Baxter County with an evaluation of an historic trees.

Forest Health: A detection flight was conducted in the western and southern parts of the state in June. The purpose was to look for infestations of bark beetles of the genus Ips. Ips bark beetles are distinct from the Southern Pine Beetle (SPB) in that Ips beetles usually kill individual or small groups of pine trees whereas SPB can kill large acreages of pine trees. No Ips beetle killed trees were detected on the flight. SPB detection traps were set out in early spring, and reported on last month. No SPB were detected in the traps.

An aerial survey was conducted to investigate the browned appearance of white oaks, *Quercus alba*, on or near the Ozark National Forest in northwestern Arkansas. The flight occurred on June 19, 2017. Several flight transects, spaced approximately four miles apart, spanned across Crawford, Franklin, Madison, and Washington Counties. Polygons were mapped with the tablet-based Digital Mobile Sketch-Mapping tool. For this survey, a 1,920 meter grid (~911 acre cell size) was used to assigned properties such as damage code and percent forested area affected.

Two locations in southern Washington County were ground-truthed to verify the cause as jumping oak gall with various degrees of oak anthracnose symptoms. White oak trees in this area appear brown and some defoliation has occurred. Most white oaks in the affected area show symptoms, and this results in a forest landscape with uniformly scattered brown trees. The situation is alarming to the public due to high visibility from major roads. A close examination reveals that many symptomatic trees still have some green foliage as most leaves are not entirely brown and desiccated.

Reforestation: Reforestation Manager and Reforestation Foreman attended the 34th Southern Forest Tree Improvement Conference (SFTIC). SFTIC is a biennial conference that brings together the greatest minds in forest tree improvement across the US and many other parts of the world. The meeting was held at Melbourne, FL and attended by 84 tree improvement professionals from 6 states, 3 foreign countries and 11 Universities.

Baucum Nursery: AFC's Baucum Nursery produces hardwood and pine seedlings for reforestation and afforestation efforts.

Baucum conducted normal cultural practices for the FY18 crop during the month of June. And, completed planting of the FY18 crop. The following pounds of seed were planted in June.

Tree Improvement: AFC's tree improvement program strives to provide landowners with the highest possible genetic gain in pine and hardwood seed. One method AFC employs to achieve this objective is by establishing the highest genetic gain material in our newest pine and hardwood seed orchards. AFC Baucum Nursery then makes available to landowners the improved varieties of pine and hardwood, which are the net result of the tree improvement program.

During the month of June, the Bluff City Tree Improvement staff performed routine maintenance associating with Shortleaf and Loblolly Pine orchard and test maintenance, including spraying herbicide, fertilizing and inventorying. They also planted 120 bare root pine into 2 gallon pots for rootstock for future grafting.

Best Management Practices: AFC provides BMP training to loggers and timber companies, conducts courtesy exams prior or during timber harvest operations and addresses logging complaints.

In June, the BMP coordinator responded to one timber harvesting complaint in which was in Cleburne County. The complaint involved hydraulic fluid on the ground from a ruptured hydraulic hose on logging equipment. The complaint was addressed and mitigated.

The BMP coordinator provided one training session in June. The training was provided in partnership with the Cooperative Extension Service as part of their Forester Training Day held in Arkadelphia. The AFC training module was on Skidder Stream Crossings with 206 registered foresters from around Arkansas attending.

The BMP coordinator continues to work with the Arkansas Forests and Drinking Water Committee. The Committee is planning a south central forum to be held at De Gray Lake Lodge in November.

The BMP coordinator represented the Department of Agriculture for the fourth meeting at the Arkansas Department of Environmental Quality Review of the Assessment of Methodology for the 2018 303 (d) listing cycle. This workgroup is made up of 30 educated and informed individuals invited to provide input. During our first meeting we discussed the Assessment Methodology, General Standards and Biological Integrity. The second meeting we discussed Specific Standards, Turbidity, Dissolved Oxygen (other than continuous data). The group will continue to work into 2017.

The BMP coordinator represented AFC at the Southern Group of State Foresters Water Resources Committee in Rogers, Arkansas. The water committee meeting agenda included a research update, Geographic Information System update on BMP monitoring site selection, story maps, and pre-harvest planning tool. We also looked at Federal water policy items, Waters of the United States (WOTUS), and discussed individual state reports.

The BMP Coordinator joined a team composed of a USFS water quality expert and other state BMP specialists to provide a peer review of the Texas BMP program. They spent a day to focusing on the nine elements of the BMP program and a ½ day in the field to evaluate methodology.

Forest Inventory and Analysis: AFC in cooperation with the USDA Forest Service Southern Research Station is responsible for collecting scientific data from permanently established plots located all over the state. The plots, each representing 5,937 acres, are strategically located on a three-mile by three-mile grid. The inventory plots have been generating data since they were established in the 1950's. Natural resource managers use the data to make management decisions and follow Arkansas' natural resource trends through time.

FIA completed 112 plots for the month of June.
