SUBJECT: COLLECTION AND DISTRIBUTION OF GENERAL AND SPECIAL REVENUES - 2016-2017

Attached is the 2016-2017 Annual Revenue Report, which includes various schedules reflecting the collection and distribution of General and Special Revenues for the 2016-2017 fiscal year. In summary, Gross General Revenue collections of approximately \$6,570 million increased \$100.3 million or 1.55% above the \$6,470.0 million collected in fiscal year 2015-16. Adjusted Net General Revenues available for distribution of \$5,348.8 million decreased \$19 million or -0.4% under the \$5,367.8 million available for distribution in fiscal year 2015-16. Gross Special Revenues of \$2,185.9 million increased \$39.7 million, or 1.8% more than the \$2,146.2 million collected in fiscal year 2015-16.
