



Comparison of Arkansas Applicant Pool by District




Arkansas Resident Matriculants


Comparison of Arkansas Resident Matriculated Students by District




District 1Comparison of Applicants and Matriculants




District 2Comparison of Applicants and Matriculants




District 3Comparison of Applicants and Matriculants





District 4Comparison of Applicants and Matriculants

In 2006, the minimum number required for each congressional district increased from 26 to 28. The number of Arkansas residents represents the number who submitted AMCAS applications and this figure is used each year for comparison to previous years. However, some applicants may withdraw their application prior to Committee review. The figures for Congressional Districts represents the number actually reviewed by the Admissions Committee. In 2006, non-Arkansas residents were placed on the Alternate List for the first time. In 2007, the law changed the congressional district allotment to 70% of the FIRST 150 enrollment positions. Therefore, we must have 27 from each district. Any enrollment positions in excess of 150 are to be awarded to **best qualified**, regardless of congressional district or Arkansas residency status.

Dear Mr. Ferguson:

Act 1058 of 2007 changed the Community Match Loan and Scholarship program to the Community Match Loan and Rural Physician Recruitment program. The new program allows physicians who are either in their residency training or no more than two years out of training to match with a rural community and receive a financial incentive for practice in that community.

The last time freshman students were added to the Community Match Loan and Scholarship program was in April 2006. In April 2007 three physicians were added to the Community Match Loan and Rural Physician Recruitment program. One began practice this summer and two are currently completing their residency training.
