 Resolution Commission appear again at the September meeting of the
 committee to review the rules after the commission inserts the amount of fees
 to be charged in two rules. The two rules are the Continuing Mediation
 Education Requirements for Certified Mediators which involves a

recertification fee and any delinquent filing fee; and the Requirements for the Certification of Mediators for Arkansas Circuit Courts which involves an application fee. The issue is that the amount of the fines are not expressly provided for in the rule.

- 4. The committee reviewed the Arkansas State Police, State Fire Marshal's rule that clarifies that fire sprinklers in new one and two family dwellings will not be a state mandated requirement in the next edition of the Arkansas Fire Prevention Code (estimated 2012 Edition). Lt. Lindsey Williams indicated that the following paragraph will be removed from the final filing of the rules:
 - "(B) Cities and Counties and other political subdivisions of this state may address and adopt at their own option local ordinances for the use and installation of automatic fire sprinkler systems in new one and two family dwellings."
