Annual Report- Court Security Grant Program; Act 576 of 2007

Date: July 18, 2009

Act 576, section 1 of 2007, codified as Ark. Code Ann. § 16-10-1006, provides as follows:

Court security grant program.

(a) The Administrative Office of the Courts shall administer a court security grant program for the purpose of providing financial assistance from funds specifically appropriated for that purpose to city and county governments to assist in the implementation of local security and emergency preparedness plans for circuit courts and district courts.

The Act further states that on July 31, 2009, the Administrative Office of the Courts shall provide an annual report to the Legislative Council that shall include the number of grant requests received from cities and counties and the number and amount of grants approved.

The grant program was divided into three rounds. The grants were awarded to the counties that completed and submitted the requested plans by the stated deadlines. To be eligible for funding in Round 1, the county had to satisfy the Facility Assessment requirements:

1. Facility Assessment. An assessment of each building in the county in which (a) circuit or district court proceedings are held or in which (b) circuit or district court employees are located must be completed and submitted to the Supreme Court Committee by January 1, 2008.

Round 2 required compliance with these requirements:

2. Court Security Plan. A Court Security Plan which outlines the policies and procedures to be followed in order to prevent and respond to court security incidents must be completed and submitted to the Supreme Court Committee by July 1, 2008.

3. <u>Emergency Response Plan</u>. An Emergency Response Plan which outlines the policies and procedures to be followed in order to prevent and respond to non-emergency related incidents (fire, weather, medical emergencies, etc.) must be completed and submitted to the Supreme Court Committee by July 1, 2008.

## Round 3 required the following:

4. <u>Continuity of Operations Plan (COOP)</u>. A Continuity of Operations Plan which outlines the policies and procedures to be followed to ensure continuous performance of essential court functions, either in the court facility or at an alternate site, in the event of an emergency must be completed and submitted to the Supreme Court Committee by March 1, 2009.
