A brief discussion was held on whether the State Board of Public Accountancy may have violated the Freedom of Information Act, based on earlier testimony to the committee, that a "rules subcommittee" of the board met prior to the board's public hearing on recent amendments to its rules. Ms. Leveta Ray of the board said that she misspoke and that only one member of the board reviewed the comments in advance of the board meeting. The other member's term had expired and therefore did not

participate. The committee was concerned about this prior testimony since, if two board members meet, a public notice is required.

- 3. On the Department of Education's rule on Professional Development, the department indicated that they would make a change on section 3.12 which "provides clarification for the term 'illness' to mean disorder of health of an educator or an educator's immediate family (§ 6-27-1202) that is verified by a written sworn statement of the attending physician" to clarify that "a written sworn statement of the attending physician" simply means a doctor's excuse.
- 4. In discussing the Department of Health, Health Facilities Services rule titled "Criminal Record Checks for Employees and Operators of Home Health, Hospice and Private Care Agencies," the committee noted a public comment on Section IV, Evidence of Criminal History Record Checks. The comment indicated that the language in Act 762 of 2009 specifies that only applicants to which the agency intends to make an offer of employment must have a background check completed. The comment suggested that the clarification could be accomplished by adding the following definition of "Applicant" in Section III: "Applicant means an individual to whom a service provider intends to make an offer of employment for a position which meets the definition of an Employee as defined in this section." The committee recommended that this change be made, and that the same change be made to the rules concerning criminal history record checks for home health and hospice agencies.
- 5. The Department of Higher Education's rule titled "Arkansas Academic Challenge Scholarship Program" will be reconsidered at the committee's February 4, 2010 meeting after the Legislative Lottery Oversight Committee reassesses the rule at its January 21, 2010 or subsequent meetings.
- 6. Upon the agency's request, the Department of Human Services, Medical Services Division rule titled "ARKids First B Provider Manual Update #85" was not considered.
