RE: Arkansas Department of Correction, One Day Tours

Dear Senator Wilkins and Representative Maxwell,

As requested during the Legislative Council meeting on Tuesday, April 16, 2010, attached are listings by both county and judicial district of the number of persons who have been ordered to attend a One Day Tour at a Department of Correction facility over the past five calendar years. The numbers for the males for all years and the numbers for the females for CY08 and CY09 include everyone ordered to tour whether they showed up for the tour or not. The only numbers available for females for CY05, CY06, and CY07 include only those that actually toured.

I do not have any information regarding how the courts feel about the effectiveness of the tours although it appears that the districts are consistent in the use or non-use of the program. The numbers for CY09 show some decline from the levels reached in CY08.

The Department of Correction works with the courts to schedule the tours in advance. Tours are conducted two days per month and the only persons turned away are those that do not have the appropriate paperwork or those that fail the drug test conducted immediately prior to the tour.
