Collections of Gross General Revenues year-to-date of approximately \$864 million have increased \$5.2 million, or .6%, above the \$858.8 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$373.7 million increased \$1.1 million, or .29%, from the \$372.6 million available for distribution in August 2010. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,129,339.71 from Corporate Income Tax to the Workforce 2000 Development Fund for a current total of \$4,259,009.42.
