HIGHLIGHTS OF THE MONTH AND YEAR-TO-DATE COLLECTIONS

Collections of Gross General Revenues year-to-date of approximately \$435.8 million have increased 8.8 million, or 2.1%, above the \$427 million collected last fiscal year-to-date. Net General Revenue Available for Distribution this month of \$377 million increased \$6.4 million, or 1.7%, from the \$370.6 million available for distribution in July 2010. In accordance with Act 1315 of 1999, the Chief Fiscal Officer of the State transferred \$2,129,669.71 from Corporate Income Tax to the Workforce 2000 Development Fund.

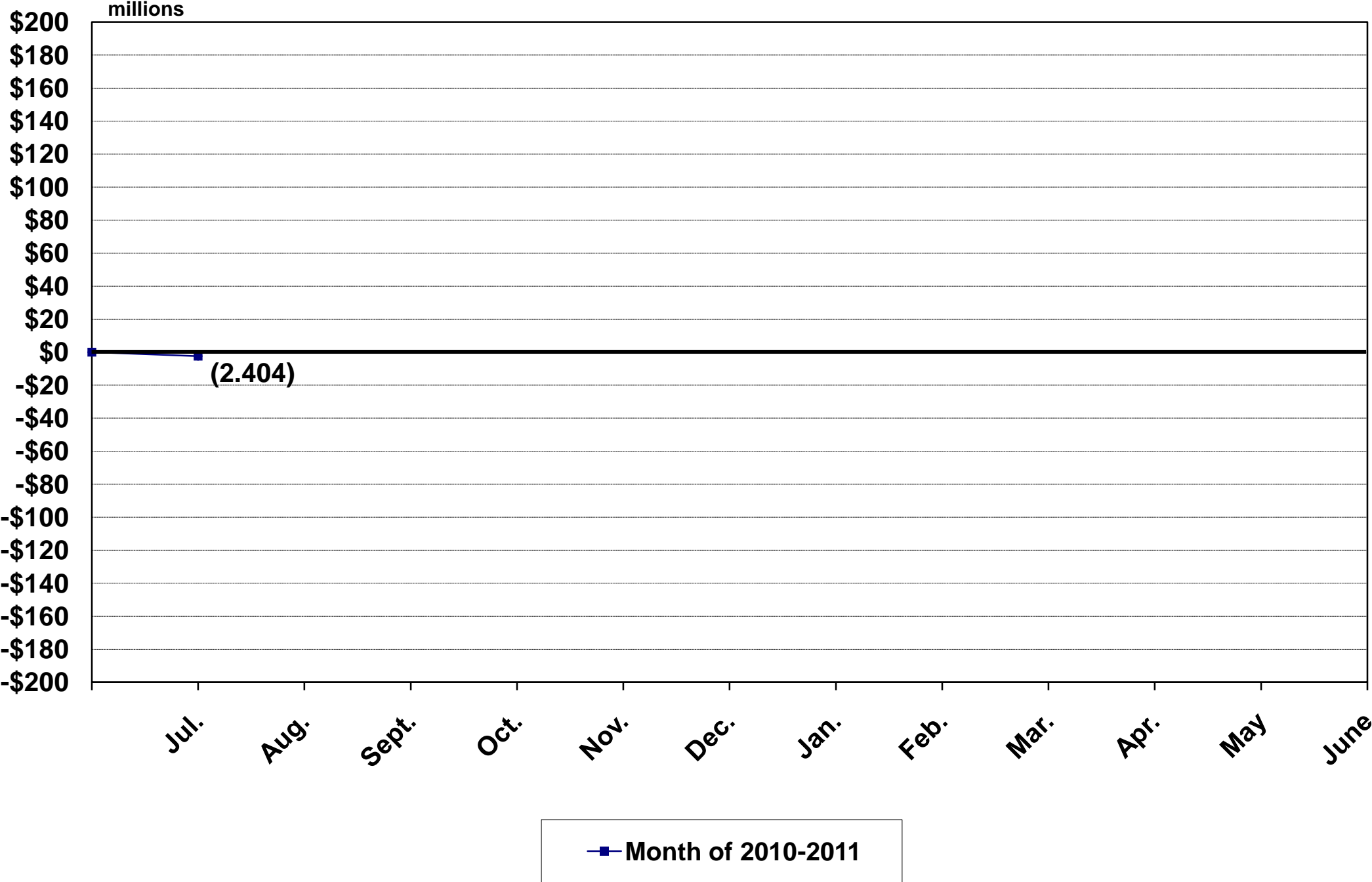
