Disability Determination for Social Security Administration (DDSSA)

Previously this year, the Personnel Committee approved 92 pool positions to help the federal government eliminate the backlog of federal disability cases. In Phase 2 of this process, DDSSA is requesting fifty (50) additional DDSSA Adjudicator V, positions whose workload will primarily focus on Arkansas claims. All of these positions are 100% federally funded.
