#### **CURRENT SPECIAL LANGUAGE (WITH AGENCY REQUEST)**

#### REVISED AGENCY REQUEST

HUD HOME PROGRAM DISBURSEMENTS. The Disbursement of funds appropriated in the HUD Home Program of this Act shall be in accordance with the State of Arkansas Consolidated Plan developed and administered in part by the Arkansas Development Finance Authority and shall be in accordance with project requirements and regulations of the U. S. Department of Housing and Urban Development HOME Program

The provisions of this section shall be in effect only from July 1,  $\frac{2018}{2019}$  through June 30,  $\frac{2019}{2020}$ .

HUD HOME PROGRAM DISBURSEMENTS. The Disbursement of funds appropriated in the HUD Home Program of this Act shall be in accordance with the State of Arkansas Consolidated Plan developed and administered in part by the Arkansas Development Finance Authority and shall be in accordance with project requirements and regulations of the U. S. Department of Housing and Urban Development HOME Program

The provisions of this section shall be in effect only from July 1, 2018 2019 through June 30, 2019 2020.

#### **CURRENT SPECIAL LANGUAGE (WITH AGENCY REQUEST)**

#### LEGISLATIVE RECOMMENDATION

INVESTMENTS. All funds that are held in at any trust fund time in the Landfill Post-Closure Trust Fund, Hazardous Substance Remedial Action Trust Fund, and Petroleum Storage Tank Trust Fund administered by the Arkansas Department of Environmental Quality may be invested and reinvested, subject to the written approval of the Office of the Treasurer, to the extent feasible, and all investments as authorized for use by the Office of the Treasurer may be available to the listed funds. The movement of these funds into and out of investments shall be by fund transfers as directed by the Director of the Arkansas Department of Environmental Quality or her designee.

The provisions of this section shall be in effect only from July 1, 2018 2019 through June 30, 2019 2020.

INVESTMENTS. All funds that are held at <u>in</u> any <u>trust fund</u> time in the Landfill Post-Closure Trust Fund, Hazardous Substance Remedial Action Trust Fund, and Petroleum Storage Tank Trust Fund administered by the Arkansas Department of Environmental Quality may be invested and reinvested, subject to the written approval of the Office of the Treasurer, to the extent feasible, and all investments as authorized for use by the Office of the Treasurer may be available to the listed funds. The movement of these funds into and out of investments shall be by fund transfers as directed by the Director of the Arkansas Department of Environmental Quality or the Director's designee.
