TRANSFER PROVISION. After receiving approval from the Chief Fiscal Officer of the State, and prior review by the Arkansas Legislative Council <u>or Joint Budget Committee</u>, the Office of Attorney General is authorized to transfer appropriation from any line item authorized in Section 3 Appropriation - Operations of the Office of Attorney General in this Act to any other line item authorized in Section 3.

The provisions of this section shall be in effect only from July 1, 2016 2017 through June 30, 2017 2018.

Auditor

TRANSFER PROVISION. After receiving approval from the Chief Fiscal

Officer of the State, and prior review by the Arkansas Legislative Council <u>or Joint Budget Committee</u>, the Auditor of State is authorized to transfer appropriation from any line item authorized in Section 3 Operations to any other line item authorized in Section 3 and the Agency is authorized to transfer appropriation from any line item authorized in Section 5 Unclaimed Property Program to any other line item authorized in Section 5.

The provisions of this section shall be in effect only from July 1, 2016 2017 through June 30, 2017 2018.
