I am filing this complaint because I have been discriminated against and my reputation has been slandered in the state of Arkansas by the Director of the Arkansas Bail bonding board. Back in June of 2017 I applied for a bail bonding job with a company in Arkansas I was told to submit my info to the company and that I would be hired. The next day after submitting my info I called the company the next day and the owner told me that the director of the bail bonding board Larry Peters told him that he would have to meet with him so he could tell him if he could hire me. So I asked him when if I could come to the meeting because I was curious about the director whom I had never met, having a meeting with a company owner concerning my employment so I wanted to take this opportunity to meet the director. But the owner told me I couldn't attend this meeting that it was a private meeting between him and the director and that all bb companies have to meet with the director and get him permission before they hire a new bondsman and didn't hear from the company owner for a couple of days so I called and the secretary told me that the company owner went to the meeting and the director Mr. Larry peters told him not to hire me because I am not a good person I have a record so I told her I wanted to talk to the owner I would call him I called the company owner and he told me not to say anything because he didn't want to get in trouble but the director of the bb board mar Larry peters told him he couldn't hire me because I was not a good person I am a conceited black man with dreads and I have a record and I don't deserve that position of authority I filed a complaint with the governor's office which I haven't heard anything else about the guy I talk to at the governor's office told me that it was illegal for the director to tell the companies who they can and can't hire and that he would handle it but I never heard from him so I tried calling him several times and he answered the phone pretended to be someone else and told me he wasn't there so finally I called and talked with Mr. Larry Peters and told him what the company owner had told me and he laughed and said yes I heard you called the governor's office on me why don't you hire the lawyer that you had to call me and check on your license because you're going to need him to get your license..... ever since then I have been trying to get companies to sponsor me they will take my info and check with him and he will tell them not to hire me. my career is ruined in Arkansas because of Larry Peters the director of the bail bonding board. Because

of him committing this illegal un ethical act ,slandering my name and ruining my career I would like for my license to be approved without having to get a company to sponsor me. I feel sorry for all the Black men with dreads who had to go through this before I did and gave up. My goal is to make sure no one has to never go through this again.

ORDER

Now before the Arkansas State Claims Commission (the "Claims Commission") is the motion filed by the Arkansas Professional Bail Bondsman Licensing Board (the "Respondent") to dismiss the claim of Andre Crump (the "Claimant"). Based on a review of the motion, the arguments made therein, and Arkansas law, the Claims Commission hereby finds as follows:

- 1. Claimant filed his claim on July 15, 2019, alleging that the actions of Respondent's director ruined his career. For relief, Claimant requested that his "license to be approved without having to get a company to sponsor me."
- 2. Respondent filed a motion to dismiss, arguing that Claimant is only requesting injunctive relief, which is beyond the jurisdiction of the Claims Commission.
- 3. Claimant responded, arguing that he has "evidence that supports my claim" and that he is "asking for an Arkansas license to be issued to me and I would also like to be compensated for the time in which I have been deprived from obtaining a license in Arkansas after [I] . . . passed the exam."
- 4. The Claims Commission agrees with Respondent that it is not authorized to award injunctive relief to a party. *See* Ark. Code Ann. § 19-10-204. In other words, the Claims Commission has no authority to order Respondent to issue a license to Claimant. Claimant's request for injunction relief should be directed to a court of general jurisdiction. *See id*.

- 5. Additionally, Claimant's claim appears to be against Respondent's director individually, which is also outside the jurisdiction of the Claims Commission. Should Claimant wish to pursue that claim, it should be directed to a court of general jurisdiction.
- 6. As such, Respondent's motion to dismiss is GRANTED, and Claimant's claim is DENIED and DISMISSED.

IT IS SO ORDERED.
